Public Comment: Public Comments on Non-Agenda Items is limited to TWO MINUTES (2) per speaker. Time may be adjusted at the Chair's discretion. Public calling in, please press *9 on your phone to raise your hand to speak. For those that are using the Zoom Webinar please use the raise your hand feature to speak. Public comment on agenda items will be heard when the item is up for discussion. Public comment on agenda items is limited to 1 minutes per agenda item. Comments from the public on agenda items will be heard only when the respective item is being considered. Time may be adjusted at the Chair's discretion

SB 411 Updates: In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires

registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

- 1. Meeting was called to order at 5:02 PM after determining quorum. Pat Bates, Glenn Bailey and Henry Eshelman were in attendance from Encino.
- 2. Reports from Public Officials/Departments/Community Agencies/Candidates-none were present
- 3. General Public Comment on Non-Agenda Items Board member Laure Stevens inquired about whether any other Encino schools had requested or could request NPGs.

4. NEW BUSINESS: Discussion and possible action:

- a. <u>NPG Southern California Garden Club</u>: Pat Bates recused herself and left the meeting, noting that the had consulted with the City Attorney, and because she is a member of multiple horticultural organizations including the southern California Garden Club, and she leases a plot at the Sepulveda Garden Center and is negotiating the formation of a Garden Advisory Board with the City, she prefers not to be party to recommending a grant that will benefit the facility. After discussion among Glenn Bailey and Henry Eshelman with public input the following was adopted: **Motion: The Encino** Neighborhood Council finance committee recommends that the ENC Board approve the Neighborhood Purposes Grant to the Southern California Garden Club assist with renovating the Sepulveda Garden Clubs, Inc. be included with the application (2) Line 3 of the NPG application form be corrected to list California Garden Clubs, Inc. as affiliated organization (3) that evidence such as minutes be provided indicating determination of the signers of the application. - b. <u>2023-2024 Budget Revision 2</u>: After discussion and public comment the draft 2nd revision was modified and the attached 2024-2024 Budget - 2nd Revision is recommended to the board, (Glenn/Henry 3 yes/0 no/ 0 abstentions)
- 5. Committee Member comment on non-agenda items. Henry again noted that someone needs to step up as treasurer.
