 - ii. Purpose and Goals - Ventura Blvd Beautification (ala Tarzana, Sherman Oaks, and Studio City), Improvement, and all things sidewalks and related walkways.
 - iii. Different purpose and goals from PLU & Traffic/Transportation Committees.
4. Review of the Bylaws: Article V, Section 7: Absences - Any Board member who misses four (4) total regularly scheduled Board meetings during any twelve (12) month period will be automatically removed from the Board. Each Board member absence shall be recorded in the Council's meeting minutes or other manner of Council record keeping, and that, upon missing the required number of Board meetings for removal, the Council Presiding Officer shall notify the Board member and provide notice to that Board member that their seat has been declared vacant. Any regular meeting of the Board, scheduled and noticed as per the Brown Act, shall constitute a meeting for the purpose of determining Board member attendance.
5. Public Comments-Comments from the public on non-agenda items within the Board's subject matter jurisdiction.
6. Closing comments by Committee Chair.
7. Adjournment.
