4. New Business:

- A. ENC Logo Pens vendor is ABC. Pens are from the same vendor as before and will be the same as we have had in the past. Quote is for \$366.57...cost might go up slightly due to length of time quote was received. Requesting up to \$385.00 for ENC logo pens.
- B. Encino Family Festival formally Taste of Encino (10/8). Booth fee is \$375. Additional fees are \$100 for an electrical outlet (good if we use the popcorn machine) & \$100 for a corner booth. A corner booth might be good depending on what we would like to do at the event. Event is October 8th, 2017. Would like to request up to \$600 for booth/space reservation only.
- C. Children's Bike Safety Event at Encino Family Festival Alta Planning offers children a workshop on bike riding and safety. Would be a great addition to the Encino Family Festival. Requirements are a space the size of 2 basketball courts. If we have a corner booth at the event the space might be next to us and available, need to coordinate with Chamber. Cost is \$200 per hour, they will provide bikes and helmets. Need a minimum of 3 hours to come out. If the Chamber OK's the space would like to request up to \$700 for Alta Planning to be at the event.
- D. Supplies for Family Festival ENC needs additional items to hand out. Requesting up to \$600 for items to hand out. All should have the Encino Neighborhood Council and web address on them. Also part of the requested amount will be for popcorn for the machine and bags with the ENC text and web address.
- E. Disaster Preparedness Event (10/7) Looking to purchase glow sticks with "Encino Neighborhood Council" & web address on them. Vendor is The Glow Store, Inc. 500 glow sticks up to 2 colors can be ordered, green and white? Total cost with shipping is \$654.47. Additional items might be requested as the event date nears. In addition we should look at having a flyer printed with planning on escape routes for fire, earthquakes and other natural disasters.
- F. Youth Seat for the ENC the Education Committee has not requested the assistance of the Outreach Committee as of yet. Would the Outreach Committee like to create a flyer to be distributed to local youths to encourage multiple applications for the seat?
- G. August 1st is National Night Out Night this is where the LAPD mingle with the residents in their community. Currently West Valley LAPD are hosting a movie at the park and we could have a table at their park, however it is not in Encino discussion on whether or not we should attend.
- H. Community Get Together II residents would like to organize another community get together looking at a date in the fall, perhaps a three hour window with food trucks at Encino Park.

5. Future Outreach Projects/Events:

- A. End of the year meet and greet at the Community Center for ENC board members and residents. Invite Koretz and other City officials with food the ENC meeting could be held afterwards to encourage the residents to stay for the meeting?
- B. LAPD Lack of available units in Encino. At the General ENC meeting the LAPD rep stated that at night officers no longer respond to non-emergency calls because only 2 units are available?? Is that for Encino or all West Valley how can the ENC ensure residents that calls will be handled when LAPD is called?
