1. Call to Order. Roll call.

#### 2. Public Comments on Non-Agenda Items:

Limited to TWO MINUTES (2) per speaker; total time for all public comment is limited to 10 minutes. Public is asked to fill out a speaker card and hand it to the Committee Chair.

Public Comment: A gentleman spoke regarding Bull Creek and the homeless that are in the area. He suggested to create public camping grounds, with facilities and let the homeless live in the campgrounds as long as they help clean the area and to open the campground to the public (at a cost).

Lee was not in attendance – tabled until the August 5<sup>th</sup> 2019 Outreach Committee meeting.

B. **Encino Family Festival** – Continued Discussion about pet adoption at the Family Festival.

Discussion regarding the pet adoption and fun walk/course continued. We need a definitive \$\$ amount for the pet adoption event – a blanket \$15K seems to be too much. In order to get sponsorships we need a breakdown, minimum amount. We will contact the Chamber to get a cost.

C. **Community Clean Up** – Discussions on Nextdoor about a community cleanup. The ENC passed a motion to have a monthly cleanup with equipment donated. We're looking at a Stakeholder to take the lead and coordinate the effort. Areas of cleanup are concerns given the steps the ENC is taking to cleanup the basin.

Although several want to participate in the cleanup, residents were invited to the meeting yet only one showed up. We will continue to coordinate the effort for a monthly cleanup. Many complaints are about bulky items, an education on using the 311 app should take place – perhaps on the ENC website and distributed to our residents. Issue is that the City only comes on Thursdays to pickup bulky items.

D. **Movie at the Park** – Date is set and film are set! Pizza is being provided by the Councilmember Koretz and also by Assemblymember Gabriel's office. We will have a desert truck and RAP will have activities for the kids before the movie. Discussion and possible action – What other things can we do for the pre-movie festivities? Costume contest, face painting, other ideas?

A sing-a-long was suggested – perhaps we can coordinate with Center Stage or with Chirstian from the Community Center.

E. ENC Advertising – Continued discussions regarding which advertising is best.
