 - B. Baseline Hillside Ordinance Summary By: Louis Krokover

Two items are not included in the NEW Hillside Ordinance proposal summary: Protection of the Ridgelines and Creation of Limitations regarding retaining walls.

There are Three Items of concern:

- 1) Any development near the Ridgeline should be protected by the 50/50 rule. This means that a developer could not go within 50 feet of the ridge with any structure and the height could not go within 50 ft of finish to the ridge.
- 2) Any and all existing Ridgeline homes cannot be advanced in design for future construction beyond a height limit of 18ft.
- 3) All hillside projects that are Ridgeline properties must go through a design review process to ensure compliance so that the structure fits into the topo.

There are three areas of focus:

- 1) The Ridgeline and how best to protect it.
- 2) The Hillside Ordinance and how to apply the Ridgeline and retaining walls.
- 3) That a design review council be appointed by each community to assist PLUM.

The city of Santa Monica already has guidelines which are very positive and we could adopt those into the Ordinance. Currently there's nothing on paper for our city and community to adhere to.

F. MEGA Cell Towers & Poles, Chris Spitz: VP Pacific Palisades Residents Assoc. Presentation by: Chris Spitz and Barbara Cohen

iPhones require more towers. Must create a law that will not allow towers to go up haphazardly. New phone poles are being doubled in height. Coastal commission requires permit. Towers are going up right next to homes, with no hearings. They will apply for permit which was not intended to cover this situation. There are multiple problems with poles being placed. Need a comprehensive new ordinance. Federal court cases and municipalities could do something about aesthetics. New comprehensive ordinances are coming around.

Shawn Bayliss: One of the problems is joint pole agreement. DWP and cell towers are coupled in one and city doesn't get revenue for that. Will use Federal court cases to base ordinances upon. Advise NC's to get people on board.
