## A –ZA 2013-2922-CUB-CU 17644 Ventura Blvd Lum Ka Naad Thai Restaurant

The Committee will review a proposed Conditional Use Permit to allow continued sale and dispensing for consideration of full line alcoholic beverages, for on-site consumption, with Live Entertainment consisting of up to a three piece combo and vocalist, as accessory uses, in conjunction with an existing 2,975 SQ FT Thai Restaurant, accommodating Eighty-Eight (88) seats within the interior and forty-two (42) seats within an outdoor patio seating area with a grand total of one-hundres and thirty (130) seats with hours of operation from 11:00 AM until 2:00 AM everyday within the C4-1VL and RA-1 Zones. Proposed hours of Live Entertainment are from 7:00 PM until 2:00 AM Thursday through Saturday. Proposed hours of alcohol service are the same as the hours of operation for the restaurant.
