Encino Hospital. Requested Entitlements: Zone variance to allow installation (12.28.B), Zoning Administrator Adjustment to maintain fuel cell in rear yard setback (12.28.A), and Specific Plan Project Permit Compliance (11.5.7.C).

B: CASE # 2016 - 4853. CRESPI CARMELITE HIGH SCHOOL FACILITY REMODEL Crespi Carmelite High School a Private High School (5031 Alonzo Avenue Encino, California 91316-3611) proposes to remove the existing multi-purpose building and bleachers, and construct a new sports center, parking structure, and aquatic center, as well as renovate the existing classroom building, fine arts building, and priory over four phases of development.

- <u>Phase I</u> includes construction of a state-of-the-art aquatic center with a ten-lane competition pool, shallow pool, 425 seat bleachers, restrooms, two locker/changing rooms, equipment storage and snack booth. Additionally, it includes the interim replacement of the existing lockers, bleachers and weight room with new lockers, weight room, and bleachers with 1,200 seats.
- Phase II includes the construction of a multi-purpose parking structure consisting of 266 parking stalls located in two subterranean levels and two above ground levels. The ground floor includes a theatre/lecture hall, classrooms, and laboratories designed to support the STEM (Science, Technology, Engineering, and Mathematics) education of students.
- <u>Phase III</u> includes the demolition of the existing multi-purpose room and interim bleachers and the construction of a three-story sports center consisting of a basketball court, kitchen, locker rooms, weight room, offices, press box, sports viewing boxes and 1,300 bleacher seats. Phase III would also include field seating consisting of 600 temporary bleacher seats and the replacement of 1,200 field bleacher seats, as well as a new snack bar and storage.
- Phase IV would include the renovation of the existing priory on the East Site, and the classroom building and the fine arts building on the West Site.

Crespi Carmelite High School is requesting additional Entitlements in conjunction with the Vested Conditional Use Permit.
