  - A. Valley Beth Shalom Expansion/Construction Update CPC-2008-3937-CU-SPRSPP-SPPA and ENV-2007-5578-MND. A chat with Bart Pachino from Valley Beth Shalom who will update

us on the size and scope of the Temple's Expansion. He will also inform us on how the Temple's Contractors intend to minimize noise, dust, dirt from the Construction. Where the intended staging areas for Dump Trucks and Cement Trucks will be and where the construction crews will park.

- 4. Action Items: (Discussion and Action May be Taken on these Items
  - A. FAT SAL'S (DIR-2016-1930-SPP 16901 Ventura Blvd. SPP). As a general rule ENC-PLU Committee and the ENC welcomes and encourages new business to eventuate in Encino. Fat Sal's which has taken over the old Johnny Rocket's site on the Northwest Corner of Ventura and Balboa (16901 Ventura Blvd) has become controversial due to the size of their signage and the color of their facade. Some of the questions the PLU looks forward to discussing are: 1. Whether the building conforms to the architectural drawing we saw when we initially approved the project? 2. Is the color of Fat Sal's facade in keeping with the Encino Street Scape plan as adopted and approved Approved by the City Planning Commission on March 27, 2003?

Are the signs in proportion to other businesses in the nearby area? Mr. Joshua Stone CEO of Fat's Sal's is expected to be in attendance. The PLU looks forward to a constructive dialogue with Mr. Stone.
    - The following sections of the "Encino Streetscape Plan & Design Guidelines" state:
      - Section 2.3

"New signage shall not create a visual conflict with existing signage in the same block frontage or, if at an intersection, with the signage on the other corners. All new signs, both individually, and as part of a sign program, shall take into consideration the location of various streetscape Elements such as street lights, bus shelters, and trees. In the case of trees, their initial size and growth shall be considered when determining the size and location of signage."

Section 6.2

"Paint/Colors/Surface Treatments of Commercial Buildings and Facades No more than five (5) colors shall be used per business/shop including the building itself, canopies/awnings, door and window frames, hardware, adjacent pole and/or monument signs, other than mural or mosaics on buildings approved by the Cultural Affairs Commission. Colors should relate to the overall building design and not be the dominant characteristic that is primarily used as an "attention getter" device."
