Ralphs Market at 17840 Ventura Blvd., Encino 91316 already has an ABC type 21 license which permits it to sell a full line of Alcoholic Beverages between 6am-1am, 7 days a week. Instructional Tastings will take place between 10am-9pm. The site is within 1000 feet of Our Lady of Grace and Church Preschool, Elementary Middle and Religious School, Torat Hayim Valley Synagogue, and Crespi Carmelite High School.
