- 1. The meeting was called to order at 7:07pm. A quorum established with 3 members present: Al Mass, Sherman Gamson, and Todd Rubinstein. Anni Keusseyan came a bit later.
- 2. The February 10, 2016 Executive Committee Meeting Proposed Minutes were approved; Sherman moved and Al Mass 2<sup>nd</sup> (3-0-0). (Motion required, unless no objections).

## 3. Officer's Reports:

- a. President's Report Todd mentioned the \$11,422.00 that being re-appropriated from DONE fund to the ENC account from the 2104/2015 BY in LA Council Motion 16-0203 on 2-26-2016.

- b. The EC discussed having Dawn Cotterell, Community Affairs, LADWP Groundwater Replenishment (GWR) Project speak at the 3/23 General Board Meeting.

- a. Update from Chair Ad Hoc Elections committee about all things Ad Hoc Elections 2016 Committee Meeting 1/18/16, updates, expenses & elections web tools. Outreach effort, mailers, etc.
- b. Sherman spoke about the ENC Ad for the Elections. He also asked about a Candidate forum at the next meeting.
