

Reimburse Pat Bates for copies for ENC June General Board Meeting The ENC credit card had expired for the 2017-2018 fiscal year and the copies for the ENC General Board meeting were paid out of pocket by Pat Bates. **MOTION; EXE-18-07-0004:** The ENC will reimburse Pat Bates \$102.69 for copies paid out of pocket for the June ENC General Board Meeting.
- 5. Door Tag Adverts/Flyers Dr. Allen has brought forth an issue regarding door tag adverts and flyers relating to crime in Encino. MOTION; EXE-18-07-0005: The ENC recommends introducing a motion to City Officials to create a No Flyer/Door Tag Advert List, much like the DNC (Do Not Call) list. This will provide Encino & LA City Residents an opportunity to put their addresses on a NFDTA List. Advertising companies will need to adhere to the NFDTA list before canvassing areas for home adverts. A new Neighborhood Watch Group is being formed and has requested 12 Neighborhood Watch Signs. In addition, the Encino South Neighborhood Facebook Watch Group has also made a request for NW signs.
