- 4-1 **405 Underpass** The Sherman Oaks NC would like to work with the ENC on revitalizing the underpass at the 405 and Ventura Blvd., ultimately concluding the project with a mural. Before that can happen the underpass needs improvements. We can begin the initial leg work with the SONC if we agree that we'll work with SONC and do our best to request City funds for the project. **MOTION; EXE-18-09-0016**: The Executive Committee supports teaming with the Sherman Oaks NC to start working together to revitalize the underpass at the 405 freeway and Ventura Blvd.
- 4-2 **Area Reps** Area Reps are being active in their areas. We need to ensure that Area Reps are following ENC procedures. Furthermore, we have some very active residents, it's imperative that our Area Reps work with these active residents so that we are all on the same page. This will be where a 500 acre landfill that's been closed for over 50 years use to be and the site will continue to be monitored by LA Sanitation. The property is owned by the County of Los Angeles.
