4. New Business:

- **4-1** Board Member Resignations Discussion on when board members resign. Currently nothing prevents a board member from resigning and then turning around and wanting to rejoin. Should we request the By Laws Committee to adopt a Standing Rule or amendment to the By Laws to include a "cooling off" period when board members resign? MOTION; EXE-18-10-0019: The ENC Executive Committee would like to modify the Standing Rules to include a cooling off period of _____months after a board member resigns.
- **4-2** Elections & Vetting Discussion and possible action. Other than checking an ID for an address verification should the ENC vet potential new board members and/or those that are running in the election? MOTION; EXE-18-10-0020: The ENC Executive Committee recommends that all future candidates and applicants for ENC board member positions undergo a basic background check (i.e. Been Verified).
- 4-3 Forum & Holiday Toy Drive The Outreach Committee discussed having an event in December, possible topics are Disaster Preparedness (earthquakes, etc...) or perhaps a forum on sidewalks and urban canopy (losing green space). These could be done in conjunction with a holiday toy drive, the ENC can deliver the toys to Fire Station 83 in Encino. MOTION; EXE-18-10-0021: The ENC Executive Committee supports the Outreach Committee setting up a December Forum and Toy Drive. Topic, Location, Date and Expense to be determined at the next Outreach Committee meeting.
- 4-4 Reach of the ENC The ENC needs to reach many more residents in Encino, not only to make them aware of the ENC but to also provide proper notices about upcoming projects, developments and events. The CD5 office does not have a mailing list for all Encino residents. The USPS has a program called Every Door Direct Mail. In the 91316 Zip Code there are 13,632 total delivery addresses (residential and business). In the 91316 Zip Code, there's a total of 12,664 residential address. In the 91436 Zip Code there's a total of 7,354 mailing addresses (residential and business) and a total of 5753 residential mail addresses. The cost to mail to, in the 91316 Zip (both residential and businesses) is: \$2,426.50 or for residential only; \$2,254.19. These cover 21 mail routes. The 91436 zip comes to (both residential and business) to \$1,309.01 or for residential only, \$1,024.03. These cover 19 mail routes. We can only mail 5000 pieces per day however we can spread it out over several days. With the elections coming up, this is a good way to get the word out about candidates, election site and date, and some information about the ENC, all in one flyer.

Our existing By Laws indicate that in the absence of the President, the Vice President shall act as President and is able to communicate with the City Attorney in the President's absence.
- **4-9** Removal of Alternate Kathy Moghimi-Patterson. Kathy has missed about 20 consecutive meetings. Per the City Attorney, we will need to vote on her official removal. Kathy will be emailed that her position will deemed vacant at the October 24th ENC General Board Meeting.
