E. Sergeant-at-Arm's Report (Exec Committee) 2min - Roster, Ethics, Funding & Code of Conduct

- Evan Oshan – Has the newly selected HOME Rep completed his funding training? It’s been 45 days since selected and seated at meetings – per the ENC’s Bylaws, Article XIV “Compliance”, Section 2, new board members have 45 days to complete the required training from being seated or will lose their Council voting rights. On 10/6/2020 an email was sent to the ENC’s SAA requesting to contact the newly selected representative to ensure the training was completed.

2. New Business Executive Committee (1 hour): Next coding starts at EXE-20-08-0129

- A. Encino Redistricting.** Councilmember Koretz has appointed Ricky Delagado to serve as the CD5 representative for the redistricting. Should the ENC have this as an agenda item on the General Board agenda or hold a special meeting with only this as a topic so that Encino Residents can weigh in on their opinions if Encino should remain part of CD5 or be in a Council District that only has Valley representation? Should the ENC start a Nextdoor Poll to get feedback from residents before this is an agenda item? **Discussion and possible action.**
- B. Security Cameras at the Community Center & Woman's Club** – The state of the art Community Center is missing two important elements. There are no security cameras for the CC nor the Woman's Club. It's been recently reported that people have been illegally dumping trash at the driveway of the Woman's Club Room forcing the CC to permanently install barrier so no cars can enter the Woman's Club Room drive way. Additionally the ENC's office is in the Woman's Club Room, along with equipment purchased with City funds. Ideally the City or Councilmember should cover the cost of cameras for both due to safety concerns. A CCTV system, for 10 cameras is approximately \$2000 plus installation and the cost of a monitor. Should the ENC request that Councilmember Koretz use discretionary funds to cover the cost of a CCTV system for security or should the ENC consider donating the system to the CC? **Discussion and possible action.**
- C. Co-Chair for the Homelessness Committee** – A recommendation to appoint Jodie Francisco as Co-Chair to the Homelessness Committee has been received from the Chair, Pat Bates. **Discussion and possible action.**
- D. Revising the ENC website** – DONE has requested that each NC receive a contract from their web providers. The ENC has received the contract, however, the ENC's website can be upgraded to make it more user friendly. Should the ENC request to add a website revision to the contract? **Discussion and possible action.**
- E. NC Election Worksheet** – The ENC should fill out the election worksheet to provide a location for a ballot drop off box. Possible locations are at the Community Center or Fire Station 83. We would need permission from either before the location is finalized and placed on the agenda. See supporting document: [2021 Election Worksheet](#). **Discussion and possible action.**
- F. Additional letter to be added to the last homelessness committee motion** – At the September 2020 General Board meeting the ENC approved a motion brought forth by the Homelessness Committee. In addition to the motion, the Chair of the Homelessness Committee would like to add a memorandum regarding securing high risk areas. Please see supporting document: [Securing High Risk Areas](#). **Discussion and possible action.**

- G. CF 20-1205** – Introduced by Councilmember Martinez, this file introduced on 9/22/20 requests that the department of Recreation and Parks in coordination with the Army Corp of Engineers and LA County report back in **30 days** on developing a master plan for the Sepulveda Basin, including a budget, and potential funding sources. The file mentions; 1) that the basin provides critical habitat for plants and wildlife, 2) that the plan is created with robust community engagement in addition to other stipulations. It does not offer critical protection for the native wildlife and habitat nor does it outline how the basin will recover post fires nor offer ongoing enforcement for the basin. It is critical that the wildlife area become a Federally Protected or State Protected area. Should the ENC file a CIS on CF-20-1205 requesting additional protections for the basin, outlining a master plan for the wildlife and other sensitive areas and recommend that the Encino Neighborhood Council be involved in all discussions regarding the basin by appointing a dedicated rep to be involved? See supporting document: [CF 20-1205](#). **Discussion and possible action.**
- H. Public Comment at General Board meetings** – The ENC’s Exec Committee is considering adding a section called, Multiple Agenda Item Comment for those speaker’s that may wish to speak on multiple agenda items at the ENC’s General Board meetings and perhaps Committee meetings. The Council shall provide an opportunity for the public to address the Council on each agenda item before or during Council’s consideration of the item, *unless the opportunity for public comment on the item previously was provided by a Council Committee and the item has not changed substantially since that Committee’s consideration of the item*. A member of the public wishing to speak on only one agenda item that is eligible for public comment shall be given an opportunity to speak for up to one minute when that item is considered by Council, or, at the discretion of the Presiding Officer, before consideration of the item. A member of the public wishing to speak on more than one agenda item at a single meeting shall combine and present his or her comments addressing the agenda items at or near the beginning of the meeting or by raising their hand (virtual meeting) during a segment called “**Multiple Agenda Item Comment**.” A member of the public speaking on more than one agenda item shall be allowed to speak for up to one minute per item up to a total of three minutes per meeting, including General Public Comment. **This will be the only opportunity to speak for those members of the public who have either; raised their hands in a virtual meeting or submitted speaker cards on more than one agenda item.** The Exec Committee shall decide the total amount of time dedicated to public comment, including multiple agenda item comments, between 20 – 30 minutes. Public comment on non-agenda items and multiple agenda items should be heard towards the beginning of the meeting, either before reports from public officials or immediately afterwards prior to “New Business”. If the Exec Committee can determine the procedure, the stipulations will be on the General Board meeting agenda and added to the Standing Rules per an Executive Order based on the duties and powers of the President per the ENC Bylaws, Article VI, Section 2A. **Discussion and possible action.**
- I. Chamber of Commerce Representative** – Our Chamber Representative is resigning from the Chamber Board as of December but will remain a Chamber Rep. There is a new representative that would be able to start as of December although the current rep is willing to stay on through the elections. **Discussion and possible action.**
