 - Lee and Pat are sharing Encino. Pat oversees the Winnetka and West Hills NC, Lee B oversees Tarzana & Woodland Hills.

- 4. Board Member Comment on Non Agenda Items Question to Lee if he's heard from Samuel, confirmed he's updating his training.
 - Lee B commented; he's alarmed by the restrictions and blurring of lines between government advocating for their people and certain people dictating agendas for their own use. The Civic Youth email, the intent of the academy is to introduce people to the city however they chose topics without surveying people on items they may have. Have seen other emails that are disturbing. One such came from the Mayor's office advocating to overturn a state proposition. The City should not advocate a position without it, at the very least, going into discussion in a public arena. Feels as if free speech is being penalized and the values the Country and the State of CA use to stand for are being slowly eroded away.
