COUNCIL MEETING MINUTES Wednesday, April 23, 2008 Encino Community Center 4935 Balboa Blvd. Encino 7:00 P.M.

5. Public Comments – Lee Marks, Encino Community Center Spring Classes, Summer Camp, May 30, 31, 6/1 Salute to Recreation Event. Arts for Earth Foundation – April 26 event

6. Mr. Silver moved, 2nd by Mr. Noce to approve the following consent calendar items: Passed 15 in favor, 3 abstentions.

A. Appropriation not to exceed \$300 for two "Welcome to Encino" tiles at boundary to Encino.

B. Recommendations by Planning & Land Use Committee

1. Van Nuys Airport Motion: "Whereas the Encino Neighborhood Council

supports the Residents" efforts to reduce noise at the Burbank Airport during the hours of 10pm and 7am and, whereas this change, if approved, would shift a big percentage of those noisy night flights to Van Nuys Airport, we recommend that LAWA add the exact same restrictions to the VNY FAR Part 161 Application, as outlined by the Burbank Airport proposal, attached."

Motion: "The Encino Neighborhood Council recommends that the LAWA Board reject the current RFP for the 5.7 acres on Valjean north of the Airtel Hotel and draft a new Request For Proposals to favor a business more compatible with the Hotel and more friendly to the residents in the area."

2. 5415 Encino Ave. Film Shoot Issues

Motion was made by Louis Krokover and seconded by Gerald Silver: "That the four actions be presented to the ENC board for their review and to support them against the film company. A formal letter upon board approval will be sent to the following parties:

1) Mayor's office; 2) Film LA; 3) The film company of record; 4) entire city council members

The letter will state our disapproval of how this matter has been dealt with and to stop any and all filming for at least one year at this location.

VOTE: Approved 5 / Oppose 0

3. Proposed Closure of Los Encinos State Park

Motion was made by Greg Martayan and seconded by Norma Landau: "That another letter be sent to the Governor and all legislators of action on this matter and again stress our opposition to any closure of our parks. Motion passed unanimously.

Motion was made by Greg Martayan and seconded by Laurie Kelson: "Request that the project follow a Santa Barbara / Mission style similar to the Ralph's center across the street and that we support this project with these recommendations VOTE: Approve 6 / Oppose 0

7. Additional recommendation by Planning & Land Use Committee: Westmark School Conditional Use Permit - "Request that the ENC-PLU supports the position of the Westmark

School against the actions of the DOT "

revised to recommend "that no street widening or other

improvements be required in connection with the Westmark School

Conditional Use Permit or other City permits that would require

removal of street trees on Louise Avenue or Killion Street.] Motion by Mr. Baar, 2nd by Mr. Woods. Passed unanimously.
