Whereas the ENC has received new information from the Los Angeles City Planning Department that such signage was installed without approval from City Planning as required by the Ventura-Cahuenga Boulevard Specific Plan; and

Whereas, the City Planning Department is now requiring a discretionary process of Project Permit Approval for the signage under the Ventura -Cahuenga Boulevard Specific Plan;

I hereby move that the ENC reconsider its recommendations as adopted at the December 3, 2008 ENC Meeting and that this matter be further considered by the ENC Ad Hoc Committee on Encino Commons Signage and that such Committee be requested to report back to the ENC at its meeting of February 25, 2009 with recommendations for action."
