Re: Item 9 below: Legality of Mayor's proposal to merge DONE with community development department and ensuing process of hearings. As to possible decertification of ENC, Commissioner Abrams did not state an opinion. Shared legal requirements if we choose to take this path. Approval by 3/4 of governing body, file with Department which then has 10 days to prepare and post public notice of request to decertify for 15 days in all languages on a ballot. Within 10 days of notice, the commission holds a public hearing in the NC boundaries regarding application to decertify. Request is voted on by 7 commisioners. NC must return all city-owned property and funds.
