The revised draft minutes of the ENC Ad Hoc 2012 Election Committee meeting held on July 13, 2012 contains this Consent Item recommendation to the entire ENC board:

REQUEST AND RECOMMENDATION FOR EXPENSE AUTHORIZATION FROM PREVIOUSLY ENCUMBERED FUNDS, a motion was made by Sherman Gamson,

seconded by Glenn Bailey and adopted 4-0 to recommend and request that the Encino N.C. authorize up to \$2,575 for expenses in connection with the election consisting of the following: \$1,000 for printing and mailing; \$100 for brochures; \$800 for August and September Patch ads; and \$675 for two Studio City - Sherman Oaks –Encino ads. "CONSENT ITEM"

(It was recognized there is still a question regarding the balance of the encumbered funding and there might be a need to reduce some amounts requested for the election.)

Please note: this recommendation is for the partial expenditure of last year's funds encumbered for election outreach expenses which MUST be spent prior to **September** <u>29, 2012</u> or they will be returned to the City's general fund.

PUBLIC INPUT AT ENC MEETINGS - An opportunity for the public to address the Council or Speaker on agenda items will be provided before or during consideration of the item. Members of the public who wish to be recognized on any item are requested to complete a question card for each item they wish to address, and present the completed card(s) to the Sergeant-At-Arms. Speaker cards are available at the back of the meeting room.

The Council will also provide an opportunity for the public to speak on any [Non-Agenda Items*] during <u>"Public Comment"</u>. The Council may not take any action or discuss matters addressed in <u>"Public Comments"</u>. However, the Council President may refer such matters to the appropriate Council Committees for further consideration.

* Public comments are limited to TWO (2) minutes per speaker.

* ENC COUNCIL DISCUSSION AND TIME LIMITS – ENC Councilmember's requesting to speak will be recognized by the President in the order requested. For any item, the Chairperson of the Committee, or the maker of the original motion shall have up to THREE (3) minutes to discuss the item. Councilmember's may speak up to TWO (2) minutes each on the matter unless extended by the President or Council. After all members desiring to speak on a question have had an opportunity to be heard once, the time for each Member desiring to speak again shall be limited to a maximum of ONE (1) minute unless extended by the President or Council. A motion calling the <u>"Previous Question"</u> may be introduced by any member during a Council debate.

If adopted, this motion will terminate debate on a matter and the matter will then be submitted for a vote.

VOTING AND DISPOSITION OF ITEMS - Most motions require a majority vote of the Councilmember's present and voting will be by hand vote unless otherwise decided by the Council. Unless requested for further consideration by an ENC Councilmember, any item which has been forwarded to the Council by a unanimous committee vote shall be approved as a "Consent Item" without further discussion.
