Encino residents have endured years of construction impacts, noise and congestion due to the expansion of the 405 freeway.

Alternate routes need to be found to handle the increased demand on the 405 freeway capacity.

Moved that the ENC oppose any further expansion of the 405 freeway and/or Sepulveda Blvd. through Sherman Oaks and the Sepulveda Pass, including widening, elevated trains, mono-rail trains, elevated car pool lanes, toll lanes or express lanes on the 405 freeway. The burden of providing more cross mountain passage must be shared by alternative routes, rather than placing more noise, traffic and congestion impacts on residents living near the 405 freeway. Ventura Blvd. traffic jams result in a significant loss of fuel, time and money to thousands of Encino residents.

Encino residents continue to experience massive traffic tie-ups on Ventura Blvd. due to roadwork conducted throughout the day, often resulting in only one lane of travel. Moved that the ENC request the LA Transportation Department and the Mayor to modify its policies to prevent massive traffic daytime tie-ups on Ventura Blvd. due to repairs or construction projects. The City should require that such road work be done on weekends, or evenings, not during the business day, except for emergency repairs. Project owners should bear the extra cost of night or weekend construction on Ventura Blvd. The name of the roadwork contractor and City phone numbers should be prominently displayed on projects during construction, to allow motorists to report tie-ups to proper authorities. PUBLIC INPUT AT ENC MEETINGS - An opportunity for the public to address the Council or Speaker on agenda items will be provided before or during consideration of the item. Members of the public who wish to be recognized on any item are requested to complete a question card for each item they wish to address, and present the completed card(s) to the Sergeant-At-Arms. Speaker cards are available at the back of the meeting room.

The Council will also provide an opportunity for the public to speak on any [<u>Non-Agenda Items*]</u> during <u>"Public Comment"</u>. <u>The Council may not take any action or discuss matters addressed</u> in <u>"Public Comments"</u>. However, the Council President may refer such matters to the appropriate Council Committees for further consideration.

* Public comments are limited to TWO (2) minutes per speaker.

* ENC COUNCIL DISCUSSION AND TIME LIMITS – ENC Councilmember's requesting to speak will be recognized by the President in the order requested. For any item, the Chairperson of the Committee, or the maker of the original motion shall have up to THREE (3) minutes to discuss the item. Councilmember's may speak up to TWO (2) minutes each on the matter unless extended by the President or Council. After all members desiring to speak on a question have had an opportunity to be heard once, the time for each Member desiring to speak again shall be limited to a maximum of ONE (1) minute unless extended by the President or Council. A motion calling the <u>"Previous Question"</u> may be introduced by any member during a Council debate.

If adopted, this motion will terminate debate on a matter and the matter will then be submitted for a vote.

VOTING AND DISPOSITION OF ITEMS - Most motions require a majority vote of the Councilmember's present and voting will be by hand vote unless otherwise decided by the Council. Unless requested for further consideration by an ENC Councilmember, any item which has been forwarded to the Council by a unanimous committee vote shall be approved as a "Consent Item" without further discussion.
