Condition: Tastings not to exceed 3 times per week. We are concerned that it would become a daily occurrence and not preserve the educational value of the events. long as tastings do not exceed 3 hrs and do not go past 8PM and only occur 1 time per week. We are concerned with public safety. Ackerman/ Hudgins 5-0-0 Motion Passed unanimously

- c. <u>Outreach Committee Meeting</u> Motion(s) passed at Outreach Committee Meeting Wednesday July 15, 2015:
 - i. The committee moved and approved the amount of \$375.00 for the "Taste of Encino" Community Event on Sunday October 11, 2015, to purchase Helium filled balloons as we did last year, Water, Juice, Ice, cups, snacks & light food for ENC Board & Outreach Committee members that will man/cover the booth throughout the day from 6:00 a.m. (set up time) to 5:00 p.m. (tear down time). Moved by Todd Rubinstein/ 2nd Michelle Weisman. Motion was approved unanimously 5-0-0.
 - ii. The committee moved and approved the amount of \$175.00 for the 8th Annual Valley Disaster Preparedness Fair, on Saturday, October 3, 2015 in the rear of Fire Station 87, 10124 Balboa Blvd., Granada Hills, from 10:00 am to 2:00 pm. This is to purchase Helium filled balloons, light decorations, Ice, water and light snacks for ENC Board & Outreach Committee members that will help man/cover the booth. Moved by Todd Rubinstein/ 2nd Racquel Marshall-Cianci. Motion was approved unanimously 5-0-0.
 - iii. The committee moved and approved the amount of \$500.00 for "Movies in the Encino Park" Community Outreach event on Saturday, August 15, 2015. The Encino Community Center would like the ENC to co-sponsor the entertainment - Mad Scientist - for that of \$500 and also promote the event to the community. Moved by Todd Rubinstein/ 2nd Toni Siciliano. Motion was approved unanimously 5-0-0.
 - The movie will be Despicable Me.
 - The CD 5 will be donating the projector and screen for the event.
 - Encino Community Center will be in charge of the licensing of the film and the free face painting.
 - Encino Park Advisory Board is looking for food trucks for the event.
 - Other Community groups will be encouraged to come out and support the event.

<u>PUBLIC INPUT AT ENC MEETINGS</u> - An opportunity for the public to address the Council or Speaker on agenda items will be provided before or during consideration of the item. Members of the public who wish to be recognized on any item are requested to complete a question card for each item they wish to address, and present the completed card(s) to the Sergeant-At-Arms. Speaker cards are available at the back of the meeting room. The Council will also provide an opportunity for the public to speak on any [Non-Agenda Items*] during "Public Comment". The Council may not take any action or discuss matters addressed in "Public Comments". However, the Council President may refer such matters to the appropriate Council Committees for further consideration.

* Public comments are limited to TWO (2) minutes per speaker.

ENC BOARD DISCUSSION AND TIME LIMITS – an ENC Board member's request to speak will be recognized by the President in the order requested. For any item, the Chairperson of the Committee, or the maker of the original motion shall have up to THREE (3) minutes to discuss the item. Board members may speak for up to TWO (2) minutes each on the matter unless extended by the President or Council. After all members desiring to speak on a question have had an opportunity to be heard once, the time for each Member desiring to speak again shall be limited to a maximum of ONE (1) minute unless extended by the President or Council. A motion calling the "Previous Question" may be introduced by any member during a Council debate. If adopted, this motion will terminate debate on a matter and the matter will then be submitted for a vote.

<u>VOTING AND DISPOSITION OF ITEMS</u> - Most motions require a majority vote of the Board member's present and voting will be by hand vote unless otherwise decided by the Council. Unless requested for further consideration by an ENC Board member, any item that has been forwarded to the Council by a unanimous committee vote shall be approved as a "Consent Item" without further discussion.
