GENERAL BOARD MEETING Wednesday July 22, 2015

Location: Encino Community Center Auditorium, 4935 Balboa Blvd. Encino

 Call to Order, Pledge of Allegiance, Roll Call, Excused Absences, Determination of a Quorum, Sign-in Sheet, Public Speaker Cards, Code of Civility, & Appoint Parliamentarian:

The meeting was called to order at 7:05 PM and the pledge of allegiance was led by Raffy Astvasadoorian. Sherman Gamson was appointed as the Parliamentarian.

A quorum was established based on the attendance of board members. 2. Approval of the June 24, 2015 General Meeting Minutes (Motion required, unless no objections).

Kathy moved a motion and 2nd by Shelley. Minutes approved unanimously.

- 3. Reports from City/State/Fed Officials:
 - a) LAPD / LAFD Senior Lead Officers (SLOs) & Captains:
 - LAPD Not present
 - b) LA City Council Offices (CD5) Field Deputies & Reps: Not Present.
 - i. Deputy Raffy Astvasadoorian from Los Angeles City Attorney's office was present. He gave an update on the few cases that he was handling for Encino. He talked about the new Neighborhood Justice Program, which offers a special program for the 1st time offenders. 1st time offenders in non-criminal charges like petty theft and vandalism. The offender presented in front of panel, who decides on punishment, such as community service or some monetary fine. Once the assigned community service is completed, that charges could be dismissed.
 - ➤ Raffy also talked about the upcoming National Night Out for the West Valley, on August 4th at 7-10 pm at the Park in Reseda. He encouraged everyone to attend the event and meet their policy officers and the captain.
 - ii. Gurmet from Council CD5 office was present. She said that the lease for the old fire station is still pending.
 - ➤ She saidCD5 budget was approved for \$8.75 Million, and that street surfacing and pot hole fixings is still going on within her district
 - ➤ She also mentioned that there Caltrans is working on 101 frwy resurfacing project, which is from Studio City to Los Vergennes in

Calabasas. The work will be done at night, and will reduce the traffic to 2 lanes. The project to be completed in 2016.

- c) State Assembly or State Senate Offices Field Deputies & Reps (5 min): Not present.
- d) Federal Congresspersons Field Deputies & Reps (5 min): Not present
- e) Dept of Neighborhood Empowerment (DONE) & Related Groups: (5 min for all) not present
 - Jacki Koci, Encino Community Center Director, was present. She gave an
 update about the remodeling effort that is going on the ENC offices. She
 also, talked about the renovation at the park. The Encino park playground
 shading plans were just approved and the project will start soon and
 should be completed by January 2016.
 - Jacki also mentioned that she is working diligently with the LAPD and Councilmember Koretz office to stop the homeless and overnighters from camping at the community center and the Encino Park. She encouraged everyone to let her know if they encounter anything out of ordinary.
 - Jacki also mentioned that the 1st annual movie at the park will be held on Saturday August 15. There will be free kids entertainments and also food trucks. The movie will start at dusk.
- 4. Guest Speaker (20 min including Q&A): Jahayra Gastelum, Civil Engineering Associate, Water Recycling Planning | Water Engineering and Technical Services, LADWP Information on the Sepulveda Basin Sports Complex Water Recycling Project. This project will deliver recycled water to six customers in the Sepulveda Basin area, including Sepulveda Basin Sports Complex, Birmingham High School, Daniel Pearl High School, Independence High School, Valley Alternative School and Mulholland Middle School
 - a) Serge Haddad from Los Angeles Department Water and Power was present and talked about local water supply initiative (called as the Purple Pipe Project). He explained the purpose of this initiative and its benefit on the city as a whole.
 - b) Jahayra Gaselum, the project manager of the Purple Pipe Project. She gave a presentation and explained in detail the logistics of the project and gave an update on the projects current status. She said this Purple Pipe water will only be used for irrigation purposes.
 - c) The entire project is for 11,000 feet pipe, which will offset for 308 AFY of water each year. Each 1 AFY = 326,000 gallon of water. So, when complete this project will be saving money and water.
 - d) The Purple Pipe water is recycled water and it meets the health & safety standards. It is treated water that is currently used in many parks and golf courses through out of the state.

If so this motion should be submitted as a Community Impact Statement for Council File 14-0656.
 - ➤ The motion on the BMO and ICO was approved 17/0/1 (Todd R Abstained). Jerry Silver moved and Carol Levin seconded.

"Any new Residential construction in Encino, per the attached map, must have mandated set-back, articulation, and environmental features as described on the four attached amended pages of the Baseline Mansionization Ordinance with no building bonus for compliance.



- ii. Should the Board of the Encino Neighborhood Council support an additional allocation of \$5,000 for NCs as advocated by LA City Council Pres. Herb Wesson and Funding Rollover, retroactively, If so this motion should be submitted as a Community Impact Statement for Council File 15-0524
 - Jason Ackerman moved and was seconded by Carol Levin. The Board of the Encino Neighborhood Council supports an additional allocation of \$10,000 for NCs as advocated by LA City Council Pres. Herb Wesson and Funding Rollover, retroactively. Motion passed unanimously. 18/0/0

 Committee Meeting
- i) Motion to re-approve the Consideration of Grant to Friends of Encino for Encino Community Center Daddy Daughter Prom on Feb 20, 2015 in the amount not to exceed \$1,500.00 from the ENC Special Board Meeting held on 2/11/2015
- j) Education Committee (5 min) Motion to re-approve the Motion(s) that passed at Education Committee Meeting Sat, Jan 17, 2015 and the ENC Special Board Meeting held on 2/11/2015

 - ii. 4B RALPHS 17840 VENTURA BLVD ZA 2015-1620 Motion: The ENC PLU Committee approves the application for a type 86-Licence at Ralphs 17840 VENTURA BLVD ZA 2015-1620 as presented. Condition: Tastings not to exceed 3 times per week. We are concerned that it would become a daily occurrence and not preserve the educational value of the events. Hudgins/Ackerman 3-1-1 Motion Passed.
 - ❖ Alex Campbell from Rodriquez & Associates representing Ralphs was present. He gave brief description of the request and the type of permit that Ralphs was applying for. He said tasting will be offered 3 times a week between the hours of 4-8

 - ➤ Encino Community Center will be in charge of the licensing of the film and the free face painting.
