<u>Adriohn Richardson</u> was the sole applicant to submit an application in time for the meeting. Richardson grew up in Chicago, worked as a minister and teacher, He's currently working with Encino Charter Elementary as an Art teacher.

Richardson was confirmed by **unanimous** vote. Richardson completed Code of Conduct and but not funding or ethics yet, however because it's within his first 45 days, he is eligible to vote on non-funding items as per the ENC Bylaws.

5. Guest Speakers:

Ana Huizar; Community Coordinator Office of Community Beautification, Board of Public Works, City of Los Angeles - Resources for community organized clean ups, weed abatement, graffiti, etc.

Office of community beautification oversees contractors that remove graffiti, adopt a median program, some weed abatement, bulky item pick-up, helps organize and facilitate community clean-ups, she encouraged people to use 311 to report items to be picked or cleaned up.

Art Sanchez; Superintendent, LA Sanitation, Solid Resources Valley Collection Division - Bulky item pick- up, recycling, creating a Service Request, etc.

- Sanchez indicated that smaller trashcans are available for seniors who may not be able to move the larger cans around.
- Sanchez said he's not up to date on Tillman, that's not a solid resources issue per se.
- -Sanchez mentioned that E-Waste and toxic waste collection programs are ongoing, you can call it in and have it picked up in front of your house by calling 311
- -Sanchez stated you can report bulky items via 311, Sanitation does multi-family sweeps for bulky items every 15th and 30th around apartments because there's always something to pick up. Sanchez further explained bulky item pick-up as: mattresses, couches, and other furniture, including large metal and household appliances such as refrigerators, washers. dryers and dishwashers (also known as "white goods"), To make arrangements to have these items collected please call the L.A. Sanitation Customer Care Center 24 hours a day, 7 days a week at (800) 773-2489, at least one day before your regular collection day. Please have an itemized list ready when calling in your request use 311. This service and all previously mentioned services are offered free of charge with normal trash pick-up when prior notification is given.
- -Sanchez said homeless encampment relocation and clean-ups are complicated and not entirely under Sanitation's jurisdiction, there's a new Police unit to deal with this issue, but the City's hands are more or less tied due to litigation by homeless people and advocates.

Guest Speakers -

Alex Davis; Legislative Affairs Manager, Valley Industry & Commerce Association and Francine Oschin; Valley Industry & Commerce Association Transportation Chair

Davis:

Trip down memory lane, The Valley got on board with Measure R but rejected Measure J. This new plan (formerly known as Measure R-2) is now called Measure M, the SFVCOG put together a bottoms-up generated list of Valley Public Transit

Rejecting this proposal because it doesn't restrict development is sabotaging your children and grandchildren.

Measure M doesn't just fund transit, it funds active transportation, highways, state of good repair, as well as streets and active transportation through "local return".

People are coming here whether we like it or not, and if we do nothing traffic will go from bad to paralyzing.

Oschin:

-As a founding member of the Encino Community Council (before this body became a Neighborhood Council) I understand your frustration, and hesitance. I don't want to raise taxes and I'm concerned about development but this is the best shot for seriously reducing congestion we've had in a long time. Everyone knows the Valley got short-changed when we passed Measure R, which is why we and the SFVCOG have worked so hard to make sure that doesn't happen again with Measure M.

Ron Ziff; 1st Vice President Sherman Oaks Neighborhood Council and Land Use Committee Chair

I am with the Sherman Oaks Neighborhood Council but I'm not here on behalf of SONC, I've been characterized as being against this issue, I am not, I am asking you to read the ballot initiative¹.

- -I worked with Mayor Bradley to get the trucks off the road for the 1984 Olympics
- -I lobbied for the 788 from Arleta to Westside
- -The Sepulveda Pass is the flagship project of this measure but it's going to take 40 years
- -Only part of the Orange Line is going to be converted to light rail, and that's also going to take 40² years
- -Ziff asked for information on four things from Metro and has never heard back
- -ballot issue needs 2/3 vote to pass and 2/3 vote to rescind
- -one of the major issues, is that unlike Measure R, which featured an independent tax-payer oversight board, the oversight board in this measure is exclusive, to transit industry insiders with 10 years or more experience in the field, but requires no background in finance³ or status as an LA County Taxpayer⁴.

Jeff Jacobberger Legislative Deputy from Blumenfield's Office

-The city of LA has 15 council districts, each of those districts gets more money than any other individual city other than Long Beach. We're asking you to support CM Blumenfield's motion, regardless of how you vote on the ballot initiative.

¹ Minute-Taker's note: As an avid transit scholar I sought to correct some of these statements via public comment but was denied to opportunity to do so at the meeting. I will be referencing sections of the actual language of the measure, as it's available on Metro's Website. http://theplan.metro.net/wp-content/uploads/2016/07/Ordinance-16 72216.pdf, these comments do not represent the views of the ENC.

², Section 11. Amendments subsection b. says that projects may be moved up in the schedule by a two-thirds vote of the Metro Board but they cannot be moved back. It is highly probable that the Orange Line Conversion and the Sepulveda Pass/ Van Nuys Blvd Project(s) will be expedited via a public-private-partnership.

³ This statement isn't entirely accurate: while the measure does call for "A transit professional with a minimum of ten (10) years of experience in senior- level decision making in transit operations and labor practices" it also calls for six (6) other members from other backgrounds including "A professional from the field of municipal/public finance and/or budgeting with a minimum of ten (10) years of relevant experience see Section 8 Subsection c.1 points A-G

⁴ That is flat out wrong, see Section 8 Subsection c.3 which states "The members of the Committee must reside in Los Angeles County and be subject to conflict of interest provisions No person currently serving as an elected or appointed city, county, special district, state, or federal public officeholder shall be eligible to serve as a member of the Committee

- -"Wayne from Encino" (stakeholder): vote no, on this boondoggle!
- -Karen (stakeholder) asked the board to reject the motion because it was too broadly worded.
- -Cohen: Measure M is a bureaucratic nightmare and doesn't account for changes in technology⁵
- -Bailey: There is some truth to the second sentence but the first sentence is problematic because the ENC doesn't have jurisdiction over the whole county.
- -George introduced an amendment stating that "The Encino Neighborhood Council supports Councilman Blumenfield's motion (CF16-0187) and requests that the Valley's projects be fast-tracked". The amendment was withdrawn when it was pointed out that it wasn't very clear that the ENC was planning on taking a position on CF16-0187.
- -George introduced a new amendment, which was accepted to strip the CIS and Council File reference from the original motion and to consider weighing in on CF16-0187 separately at a later date. That amendment was accepted
- 1. MOTION: The ENC does not support the expanded transit projects across the county nor the 1/2 plus 1/2 % sales tax as they are not directly linked to limits on new development, housing, and construction. Traffic and transportation problems will never improve as long as new building permits are issued that only invite more transportation demands.
