 16161-63 Ventura Blvd (Ventura/Cahuenga Blvd Corridor Specific Plan)

Proposed project is new construction of a multi-family residential building designed by renowned Los Angeles architectural firm, TCA Architects. No variations, adjustments or variances are proposed for the project. Specifically, the proposed project includes 133 apartments and live/work units, including 11 affordable units, in a total of eight stories with the requisite step backs from Ventura Boulevard required by the Specific Plan. The proposed project is approximately 118,000 square feet with a floor area ratio of 3:1 allowable under the Los Angeles Municipal Code in conjunction with the provision of affordable housing at the project location. Pursuant to the Municipal Code and State Law, 66 at-grade and subterranean parking spaces are proposed along with additional bicycle parking. Various residential amenities are also proposed as part of the project.
