Gerald Silver: there should be no changes to zoning law other than modernization of the system. Changes in zoning laws will lead to unchecked development.
Debra George: Parks & public space should be addressed, will be topic at next Parks Committee meeting.
Gerald Silver: this should be an ongoing agenda item for future meetings.

6A1: From Executive Committee: Motion to set Wednesday, November 29, 2017 as the combined November/December Encino Neighborhood Council board meeting date, by Kelson seconded by Rosen, passed 19-0-0

6.B.!. From Outreach Committee: Motion to pay for Encino Neighborhood Council tile on 'Welcome to Encino' Sign: cost is \$750 for first year, \$500 per year for years 2 and 3. Request is for first year advertising funding of \$750. Measure was discussed, member Cohen asked where the sign is. He recommended that ENC advertise in Encino Patch. Motion by Eshelman, second by Sherman, Approved 17-1-1 (No: Cohen, Abstain: Linden)

6.B.2. through 6.B.5. from Outreach Committee: Motion to approve expenditure of (6.B.2) \$385 for 500 Encino Neighborhood council logo pens (6.B.3) Up to \$1,200 for the Encino Family Festival to be held October 8, 2017 (\$575 for booth charges with the balance for event promotional supplies), (6.B.4.) up to \$655 for glow sticks as Encino Neighborhood council promotional items for Disaster Preparedness Festival to be held October 7, 2017, and (6.B.5.) up to \$250 to purchase a table cover containing the Encino Neighborhood council logo to be used at promotional events.
