**Executive Committee (Non-Consent)** 

**A.** NC Reform CF-18-0467 – The NC Reform CF-18-0467 was emailed to the entire board (8/2/18) for review. MOTION; EXE-18-07-0002: The ENC Executive Committee supports and requests support from the Encino Neighborhood Council for CF-18-0467 if amended to not include bullet points 3 & 4. CIS to be filed.



## 8. New Business – Non-Funding Consent Items (30 minutes)

## Parks Committee:

- **A.** Committee Name. The Parks Committee would like to change the committee name to Parks and Environment to expand their scope beyond park space. **MOTION**; **PAR-18-10-0004**: The ENC Parks Committee supports changing the committee name to "Parks and Environment". **Passed 4-0-0**
- B. 60 Day Notification Period. Currently the LA Bureau of Street Services Urban Forestry Division (UFD) provide a 3 day notice for tree removal. Providing 3 days notification of the pending removal of 1-2 street trees does not give NCs and CCs adequate time to respond. As bodies that must comply with the Brown Act, it's impossible for NCs to do our due diligence and to consider a motion in such a short time frame. Likewise, on removal of 3 or more street trees, the provision of a 30 day notice is still problematic since no background materials are available until 3 days before the BPW hearing.
  MOTION; PAR-18-10-0005: The Encino Neighborhood Council requests that the City of Los Angeles Bureau of Street Services' Urban Forestry Division amend its notification guidelines to provide Neighborhood and Community Councils with adequate and additional time to respond to notifications of pending street tree removals. We urge the UFD to adopt a 60 day notification period for proposed removal of all street trees and make all background/transmittal documents available online when the notice is posted, except for removals done by the City in response to emergency damage. Passed 5-0-0.

## PLU Committee (Non-Funding Items)

C. Sherman Oaks PSH, CF#12-1549-S12 – MOTION; PLU-18-10-0003: The Encino Neighborhood Council opposes the proposed PSH at 15314 W. Dickens Street and the Crisis Bridge Housing facility at 5161 Sepulveda Blvd. due to safety concerns, health concerns, disruptions to businesses and schools, and impacts to stakeholders. Letters to Councilmember Koretz (CD5), Planning Deputy Avi Kleinman, Councilmember Ryu (CD4), Catherine Landers, Director of Special Projects and Councilmember Blumenfield (CD3). CIS to City Council. Eliot C moves, Carol L 2nds. Passed 8-0-0.

# **Executive Committee (Non-Funding Items):**

- D. Holiday Toy Drive and Forum The Outreach Committee is discussing an event for December with possible topics as Disaster Preparedness or sidewalks and urban canopy in conjunction with a Holiday Toy Drive (deliver toys to Fire Station 83). MOTION; EXE-18-10-0021: The ENC Executive Committee supports the Outreach Committee setting up a December Forum and Toy Drive. Topic, Location, Date and Expense will be determined at the next Outreach Committee meeting and to start collection toys in the November ENC General Board meeting. Passed: 4-0-0.
- E. ENC Public Safety Committee Chairs The ENC's Public Safety Committee has not met in over a year. Crime and public safety continue to be a top concern of the residents in Encino. This committee. MOTION; EXE-18-10-0022: The ENC Executive Committee recommends Suzan Richmond and Samuel Apikyan as Co-Chairs of the Public Safety Committee. Passed: 4-0-0.
- **F. Board Member Resignations, Cooling Off Period** Currently our By Laws nor our Standing Rules have a cooling off period for board members that resign and then turn around wishing to re-join. **MOTION; EXE-10-18-0019** The Executive Committee would like to modify the ENC Standing Rules to include a cooling off period of 90 days after a board member resigns and requests the By Laws committee to modify the standing rules. **Passed: 4-0-0.**
- G. Removal of Kathy Moghimi-Patterson Kathy has missed more than 20 consecutive meetings. An email to Kathy was sent on 10/19/18 advising her a vote will take place to remove her from the Alternate to the At-Large Rep Position at the October 2018 ENC General Board Meeting.
  MOTION; EXE:18-10-0024 The ENC to remove Kathy Moghimi-Patterson as the At-Large Alternate Passed: 4-0-0.

# **Traffic & Transportation Committee (Non-Funding Items):**

I. Signal timing Northbound Hayvenhurst Ave @ Ventura Blvd.

**MOTION TRA-18-10-0002:** The ENC supports adding 7 additional seconds to the Northbound Hayvenhurst Ave traffic light. Many cycles are three seconds which is not adequate for the volume of cars entering and exiting Gelson's market and the bank/medical building on Ventura Blvd. This is also a heavy pedestrian zone. We request on on-site visit with LADOT and committee members. (Kelson/Jarvis 6/0/0)

J. Crosswalk Lights on Ventura Blvd at La Maida (by the Shell Station).

**MOTION TRA-18-10-0003:** The ENC requests to add lighting to the pavement to alert drivers of the pedestrian crosswalk @ LaMaida and Ventura Blvd. NE Corner. There should also be lighted signage. (Jarvis/Bailey 6/0/0)

K. Discussion of proposed turn restrictions in the Encino Hills on Louise @ Nance and Louise @ Oak View.

MOTION TRA-10-18-0004: The ENC requests the LADOT to conduct a well publicized public hearing prior to installing any proposed turn restrictions on Louise Ave @ Nance and Louise Ave @ Oak View. (Hand/Jarvis 6/0/0)

- **L. Discussion and Possible Action: To support to increase fines for excess vehicle exhaust noise MOTION TRA-18-10-0005:** The ENC Supports the NOHO NC to increase fines for excess vehicle exhaust noise which has created an atmosphere of intimidation, fright and increased street racing. (Kelson/Hand 6/0/0)
- M. Sepulveda Blvd Northbound South of Valley Meadow- Safety Issue There is water covering the road continuously in the right lane and now flows across most of Sepulveda Blvd. causing skidding and accidents.

**MOTION TRA-10-18-0006** - The ENC requests the LADWP fix leak on Sepulveda Blvd South of Valley Meadow East side where water covering the road continuously in the right lane and now flows across most of Sepulveda Blvd. causing skidding and accidents. (Kelson/Bailey 6/0/0)

N. Stop Sign request on McCormick at Whitaker.

**MOTION TRA-10-18-0007:** The ENC requests on All-Way Stop at McCormick and Whitaker. .(Kelson/Bailey 6/0/0)

**O.** Compile a list of locations with tree roots uplifting the pavement. Street Services has done nothing for years on this issue.

**MOTION: TRA-10-18-0009:** The ENC should compile a list of locations with tree roots uplifting the street pavement. Street Services has done nothing for years on this issue. (Kelson/Hand 6/0/0)

P. Anti-Gridlock Enforcement in Encino on Ventura Blvd.

**MOTION TRA-10-18-0010:** The ENC requests parking enforcement Eastbound starting at 4PM especially East of Balboa on the South side of the street for the anti-gridlock zone. (Kelson/Hand 6/0/0)

Q. Discussion and Possible Action Re: Mission Hills Canyon Park Project

Kelson attended the first public hearing for the Mission Canyon Park Project. This proposed park is just South of our Encino Hills Neighborhood. It will cover the land of the decommissioned Mission Canyon Landfills 1,2,3. A representative of County Supervisor Shelia Kuehl was there as well as CEQA representatives. About 50 residents, mostly from Brentwood, Bel Air Skycrest, Mountain Gate and Bel Air Crest. The comment period ends on October 31, 2018. A definite flaw was that the



traffic/transportation effects were "less than significant ". The access and egress on Sepulveda Blvd is very dangerous and no one wants another traffic light.
