#### 8. Funding Requests - NPGs & Funding (Consent – 20 min):

**8-A. NPG – Valley Cultural Center**: A proposed PopUp Art Event at Encino/Genesta Park. Councilmember Koretz has agreed to contribute \$4999 to the event scheduled for August 17<sup>th</sup> 2019. **Passed by the Outreach Committee as consent, 5-0-0**.

**8-D**. **NPG** – **Hope Mill** - This \$2,000 grant will providing funding for 400 backpack CarePacks, which we will then fill with the essential survival items for the area's homeless men and women. Hope Mill partners with the Los Angeles County Department of Mental Health Homeless Services Team which will use the CarePacks for outreach in our local area including the Sepulveda Basin. Passed by the Homelessness Committee, a request in the amount of \$2,000.



#### Funding Requests – NPGs & Funding (Non-Consent):

**8-B.** NPG – Clean Streets/Clean Starts – Northridge Beautification Foundation: This \$5,000 grant request would provide funding for the Clean Streets/Clean Starts project to operate in the Encino/Sepulveda Basin area. This very successful project has done major cleanups in many valley areas, engaging homeless persons in the work.

**8-C.** NPG – Valley Disaster Preparedness Fair – This \$850 grant is a sponsorship for the Valley Disaster Preparedness Fair on October 12, 2019, giving the Encino Neighborhood council an outreach opportunity

**8-D**. NPG – LA Parks Foundation – \$1900 grant request for condenser microphones, cables, and foundation overhead for the Encino Community Center

**8-E. Languages 4 You Translation Services** – A request was made for translation services at the April ENC General Board Meeting. The ENC is required to pay for the service and the City will reimburse the ENC. The cost of the service was \$600

#### 9. New Business – Consent Items (Non-Funding):

#### **Executive Committee (Consent Items):**

**9-A. Encino Medians via the Encino BID**. The Encino BID is working on a project to install lighting in the medians within the BID boundaries to reduce the amount of collisions with the medians. **MOTION; EXE-19-05-0056**: The ENC's Executive Committee recommends that the Encino Neighborhood Council send a letter to Susan Levi (BID Controller) in support of the median project within the Encino BID providing that a BOE permit is pulled & the Board of Public Works (CONAD) administers the project. We further encourage the use of solar lighting. Passed: **4-0-0** 

**9-B. Encino Decorative Planters on street poles via the Encino BID.** The Encino BID is working on a project to add decorative planters to light poles within the Encino BID boundaries. **MOTION; EXE-19-05-0057:** The ENC's Executive Committee requests that the Encino Neighborhood Council support sending a letter to Susan Levi (BID controller) in support of the planter project within the Encino BID boundaries. **Passed: 4-0-0** 

**9-C. Dissolve the Ad-Hoc Election Committee. The ENC's elections have concluded ending the need for the Ad-Hoc Election Committee. MOTION; EXE-19-05-0058:** The ENC's Executive Committee requests that the ENC support ending the Ad-Hoc Election Committee by June 30<sup>th</sup> after a representative from the Election Committee retrieves all the election materials from City Personnel and returns it to the ENC's office. **Passed: 4-0-0**.



#### Planning & Land Use (Consent Items):

**9-D. INTERPRETATION OF CITY SIGN ORDINANCE-CITYWIDE Regarding signs on Freestanding walls. DIR-2018-6787-BSA-1A** – Applicant has challenged the department of planning & building and safety's determination that independent walls do not constitute structures, and hence signs can be placed on walls constructed in front of buildings.

Appeals question: "the overall issue involved as to whether or not the definition of a wall sign allows a wall sign to be placed on both buildings and free-standing walls or structures with four walls but no roof will generally apply to other sites in the City."

**MOTION**: The ENC PLU supports the determination and findings of the department of building and safety and the zoning administrator in case DIR-2018-6787-BSA-1A and requests that the Encino Neighborhood Council support sending a community impact statement. **Passed: 6-0-0** 

#### New Business (Non-Consent):

**Planning & Land Use:** (The hearing is June 4<sup>th</sup> 2019 – this item was heard at a PLU Committee meeting, however it is uncertain whether a quorum was met.)

**9-F: Sadaf Restaurant - Conditional Use Permit application / Case Number ZA-2019-442-CUB: Discussion and possible action:** Ms. Liliger Damaso with Liquor License Agents will represent Sadaf Restaurant located 16240 Ventura Blvd. Los Angeles, CA 91436. They have submitted a CUB application for the continued use of their type 47 liquor license for on-site consumption of a full line of liquor in conjunction with their Restaurant.
