Managed Encampment and Shared Housing: MOTION; PLU-20-02-0060:** The ENC PLU supports Council File 19-1413 if amended to include required site location approval by the area planning commission with strong input from the local neighborhood council and furthermore the ENC PLU suggests a site to be located on the paved lot next to the Tillman Water Reclamation Plant (15790 W Victory Blvd. APN: 2251002906, PIN: 177B141-4, Legal: -PT-LT B-21). 7A. Executive Committee: Alex Garay

- 1. Non-Cosent, Funding: NPG Request: Los Encinos Docent Association (See Supporting Document, NPG Los Encinos Docent Association). The Los Encinos Docent Association, a 501 (c) 3, the cooperating association of Los Encinos State Historic Park, is requesting this grant to help fund what now is a popular, annual special Summer evening event in the community a live, al fresco professional Shakespeare performance at the park. In response to positive feedback, two shows over two nights, Saturday, August 8 2020 and Sunday, August 9, 2020 at 7pm drama "Richard III" and comedy "Love's Labour's Lost" will entertain on the lawn north of the historic adobe. Grant request expenses for this special event are out of pocket and includes entertainment, portable sanitation, and staffing per special event (event occurs after normal park hours). Los Encinos State Historic Park is located at 16756 Moorpark Street, Encino, CA 91436. The NPG request, received from Amy Zidell, is in the amount of \$4,930.00 with a start date of 02/08/20, date funds required is 03/31/20 and the expected completion date is 08/10/2020.
- 2. Funding (Not routine in nature) Community Center Staff Overtime at the ENC General Board meetings: When the ENC's General Board meetings run past 9pm, the Community Center pays their staff overtime to remain to close the center. The Community Center pays their staff from their budget and they have been generous with the ENC. The Community Center should not have to absorb the cost of the ENC's meetings running past the reservation time for the room. The additional cost for the staff is \$30/hr.

 MOTION; EXE-20-02-105: The ENC's Executive Committee recommends that the Encino Neighborhood Council approve covering the cost of the Community Center's staff when meetings run past 9pm at a cost of \$30/hr. Alex G. moves, Lee B. 2nds., Passed: 5-0-0

7B. Planning & Land Use: Eliot Cohen

1. Proposal to build Elder Care Facility, ENV-2019-6480-EAF (16151 -16201 Ventura Blvd.). Case # ZA-2019-6479-ELD-SPP-SPR

SRM Development seeks to demolish and remove two commercial retail office buildings (23,991 square feet combined), a billboard sign/structure, and the associated surface parking lot; in order to construct, use and maintain an approximately 115,886 square foot Eldercare Facility Unified development built to a maximum of 77 feet in height (six stories) consisting of 107 assisted living Dwelling Units and 16 memory care Guest Rooms. Off-street parking is provided below grade within one subterranean parking level. The subject property is zoned C4-1L and located within the Ventura Cahuenga Boulevard Corridor Specific Plan.

The developer is re-engaging the committee with proposed changes to the previous design. The following changes were highlighted:

- Project revised from apartment dwelling to eldercare facility
- Project height lowered from 86' to 77' (elevator)
- Balconies on the rear side of the building were removed
- Traffic study yielded an approximate 67 less daily vehicular trips than the existing businesses generate
- Parking plans during construction not yet finalized. Committee requests adherence to the parking policy generated for the site to prevent contractors monopolizing street parking



- The project abdicated the granted waiver of dedication to give 5ft back to the sidewalk
- The project will provide a 24-hr hotline to report issues.

MOTION; **PLU- 20-02-0059**: (Cohen): The ENC PLU has no objections to the 16161 Ventura Bl proposed Eldercare Facility as presented by SRM Development as long as all the mitigation measures for the neighbors are completed in a timely manner in conjunction with the completion of the building. Moved by Eliot C, 2nd by Lee B. Passed: **7-0-0**

 - 1. The ENC Airport Committee submits the following motion for ENC approval (Passed: 4-0-0)

Whereas:

- *The residents of Encino, as well as other communities across the San Fernando Valley, have had their lives significantly disrupted by the FAA's NextGen program as implemented at Van Nuys Airport (VNY)
- *Some of the many negative community impacts resulting from NextGen include significant health, safety, and climate risks
- *Over 300K noise complaints related to VNY operations were submitted in 2019 (Compared to less than 1000 complaints in 2016, the time period prior to NextGen initially launching at VNY)
- *A Southern San Fernando Valley Airplane Noise Task Force consisting of local, state, and federal officials has been formed to collectively assess the problem and propose a Valley-wide solution encompassing both Van Nuys and Burbank Airports
- *Community groups, be they publicly elected or ad-hoc, have been encouraged by the Task Force to submit a "point of view" relative to what actions should be taken at either or both airports
- *The Task Force community input period is expected to close by the end of first quarter 2020

*The ENC approves the following letter for formal submission to the Southern San Fernando Valley Airplane Noise Task Force in support of all Encino Residents as well as many others similarly impacted in neighboring communities by the FAA's NextGen program at Van Nuys Airport.
