5A. Election Worksheet – The ENC is required to fill out the 2021 NC Election Worksheet that will indicate the location of the voting drop-off box for the 2021 NC Elections. The ENC's Executive Committee recommends using the Encino Community Center or Fire Station 83 for the location. MOTION; EXE-20-10-0129: The ENC's Executive Committee recommends that the board support using the Encino Community Center as the first choice for the NC elections drop box on May 4th 2021 between the hours of 11am – 7pm. Fire Station 83 on Balboa Blvd., will be the 2nd choice using the same hours. Passed: 3-0-0.

5B. Co-Chair for the Homelessness Committee – A recommendation by the Chair of the Homelessness Committee to appoint Jodie Francisco as Co-Chair of the ENC's Homelessness Committee. **MOTION; EXE-20-10-0130: The ENC's Executive Committee recommends to support Jodie Francisco as the Co-Chair for the ENC's Homelessness Committee. Passed: 4-0-0.**

5C. Additional Letter to be added to Homelessness Committee Motion – At the September 2020 General Board meeting the ENC approved a motion brought forth by the Homelessness Committee. In addition to the motion, the Chair of the Homelessness Committee would like to add a memorandum regarding securing high risk areas. Please see supporting document: <u>Securing High Risk Areas</u>. 5F. Motion 20-10-116 RE: The PLU Committee asks that official ENC letters be sent from the Executive Committee to the Planners for the Encino-Tarzana Community Plan and Ventura Cahuenga Planning Review Board asking for detail information about the Community Plan Updates and the specific issues mentioned in these letters. **See supporting documents:** <u>Ventura Cahuenga</u> & <u>Encino Tarzana</u>. Passed 6-0-0

5G. Motion 20-10-117 RE: The ENC–PLU recommends filing a Community Impact Statement against this motion unless amended. Whereas, the ENC PLU recognizes and agrees with both PLUM and the movers of the motion in the need to combat corruption. However, The ENC PLU believes that additional checks and balances are needed to combat possible future corruption in the planning and land use committees. Seeing as two councilmembers' have been indicted by the FBI for Planning and Land Use corruption, one being both on the City Council and Chair of PLUM, removing a layer of due diligence seems counterproductive. Whereas the ENC PLU urges more due diligence in the face of possible corruption.

Instead, of CF 20-1044 the ENC PLU suggests a new check and balance to planning projects in general. The ENC PLU suggest the use of a floating, voting seat on the APC/CPC/PLUM be created, allotted for the NC to which the project falls within. This special seat would only be filled by a certified NC member, elected by its NC., and will advocate for NC position regarding said project. See supporting document: <u>CF 20-1044</u>

- Items 5A, 5B & 5G passed as consent items, passed: 16 (Y), 0 (N), 1 (I). Items 5C & 5F were pulled.
- Item 5C Glenn Bailey brought up CF 20-0841 to add for a CIS. Pat Bates updated the concerns in the Basin and will add recommendations regarding a pallet shelter be considered in the North end of the Basin. After discussion the motion was amended to add the council file and the item was voted on and passed: 15 (Y), 0 (N), 1 (I)
- Item 5F pulled by Laurie Kelson due to the items on the letter are not within the scope of the PRB and further raised the concern that the initial letter was sent on ENC letterhead without it being discussed or heard by the board previously. After much discussion and a request for information sooner than later, the item was set to be voted on. Prior to the vote a new board member questioned whether he was eligible to vote or note. After discussion, two new items came up tabling the item until the end of the meeting and extending the meeting to 9:30pm. The item was tabled and the meeting was extended until 9:30pm. In addition the following item to be heard is item 6B.

6A. Reconsideration of PLU Motion from 9/23/20 General Board Meeting, item 5C, . Motion 20-09-115 RE: Council File 20-1011 Title: The Sherman Hotel possible Eminent Domain Acquisition of for Homeless Housing at 15485 Ventura Boulevard:

The ENC (PLU) urges the Los Angeles City Council and the City Attorney to use all legal means to oppose U.S. District Court Judge David O. Carter injunction ordering Los Angeles City Officials to create immediate shelters for the Homeless in many inappropriate venues. Passed 5-0-0

A board member that original voted to support the motion is requesting a motion for reconsideration as it was not properly agendized on the PLU Committee agenda or requesting to have the PLU Committee properly agendize the item so it can be considered by the board.

6B. Motion 20-10-115 RE: Planning Case No. is APCSV-2018-2801-SPE-ZV-SPP-SPR. Proposal to Demolish the Sherman Hotel 15481-15491 Ventura Blvd., and build a luxury boutique hotel at the same address. Presentation by Heather Waldstein from Rosenheim & Associates (10 minutes)

The ENC-PLU has no objections to the construction of an AC (Marriott) Hotel at 15481 -15491 Ventura Blvd. as presented to the PLU Committee on 10/13/2020. Additionally, the PLU Committee states: There must be strict adherence to keeping demolition and hauling routes away from residential neighborhoods. This also includes keeping the trucks while they are queuing and idling away from residential neighborhoods. **Passed: 6-0-0**



- After the presentation, members of the public had an opportunity to speak. Following public comment on the item board members had an opportunity to speak. Prior to board member discussion, the concern about being ineligible was brought up again. An objection on the point of order was brought up and after an inordinate amount of discussion, the board voted to uphold the SAA's position that the board member cannot vote due to not completing all trainings within 45 days of being seated. The vote was taken and passed: 13 (Y), 1 (N), 2 (A), 1 (I)
