## Motion, Discussion, and Vote may be taken on all items

- 1) Call to Order. Roll call; determination of quorum.
- 2) Opening comments from chairpersons
- 3) Reports from Public Officials/Departments/Community Agencies
  - a. Include discussion of CARE/CARE+ efforts, in Encino
- 4) Approve minutes of September 9, 2020 Meeting
- 5) New Business (Vote may be taken):
  - a. Council File 19-1576: Unhoused People / Acuity Levels / Los Angeles Homeless Services Authority (LAHSA) Programs The report from LAHSA addressing the relationship of acuity of homeless people to programs designed to provide housing, and how well the program is serving homeless people. The council file, the report from the Homelessness and Poverty Committee and the Report from LAHSA are accessed using the link provided. This file was on the agenda for the Homelessness and Poverty Committee meeting on November 12, 2020 it passed and is referred to the entire City Council with recommendation to ensure people of all acuity levels are helped. It appears from the report that the bulk of housing efforts are aimed at the more vulnerable (higher acuity) population and not much is being done for everyone else on the street. Proposed Motion HOM 2020 11 01: The Encino Neighborhood Council endorses action aimed at providing real solutions to helping all our homeless neighbors. This would include evaluation of the recently-introduced Problem-solving program, and its expansion if deemed effective. The report seems to indicate that for SPA 2 (our area) the rate of exits to housing of people in the system is less than 30% (FY 2018-2019). Further, the number of people in the system that year is less than half of the unsheltered homeless from the 2019 SPA 2 homeless count. Unhoused people deserve at the very least, accessibility to safe sleeping locations, sanitation and services such as storage, computer access, cellphone charging, mailboxes, and contact with outreach workers.
  - b. Council File 20-1425: Relative to P-I-T data collection of unaccompanied homeless women in the city of Los Angeles: This file was passed by the Homelessness and poverty committee meeting on November 12, 2020 and is referred to the entire city council. There has been a significant increase in homeless women. Proposed Motion HOM 2020 11 02: The Encino Neighborhood Council supports the motion and concurs with the recommendation that "unaccompanied women" be added as a category for the 2021 Point in Time Homeless Count.
  - c. <u>Council File 20-1406</u>: Description of Paxton/Bradley Pilot Project model for taking an entire encampment community from outreach intake through housing placement, including assistance with identifying and storing personal property, sanitation, trash collection and mobile showers while waiting for available housing. The motion requests LAHSA report on the protocol including recommendations for appropriate signage, documentation and personal property storage. **Proposed Motion HOM 2020 11 03**: The Encino Neighborhood Council supports this motion and recommends that this apparently successful program be expanded to existing encampment areas and possible designated safe camping areas in the future.

d. <u>Council File 19-1215</u>: this report requests explanation of discrepancy in mental illness rates between LAHSA and Los Angeles times' analysis of LAHSA data, and further requests information from LAPD's Mental Evaluation Units (MEU) and the system-Wide Mental Assessment Response Team (SMART) regarding status, usage and recommendations. This passed City Council on 9/22/20. There was no indication in the motion or Homelessness & Poverty Committee Report when the reports are due. It is John Lee's motion, perhaps his office can clarify.

Notice of Funding Availability CF 20-0941 (information only): That the City Council instruct the City Administrative Officer and the Chief Legislative Analyst to report with the status of the Homekey Program, identify eligible projects for which the City can apply, identify sources for the required matching funds, and explore partnerships with other governmental entities and mission based organizations that can leverage the City's capacity to secure funding.
- g. CDC Guide Unsheltered Homeless
- 7) Old City Council actions that await follow-up. Note that all these passed city council. Following all of these to see if there is follow-up in action and/or reporting.
  - a. **Council File Motion** 19-0780 that the City Council instruct the City Administrative Officer and Chief Legislative Analyst, and request the assistance of LAHSA and the Office of the Mayor, to report on the feasibility of entering into public-private partnerships with interested non-profit agencies for management of distributed micro-storage services, including any potential costs and available funding sources for such a program and the ability to enter into a pilot program to precede a wider program rollout. The west San Fernando Valley desperately needs storage facilities for persons experiencing homelessness. With the enhanced sweep activity leading up to the 2020 Point in Time Homeless Count, many homeless people throughout the San Fernando Valley lost their possessions. The measure passed December 12, 2019. Is anything being done? If not, why not. If the SFV is not being included in any plans, why not?
  - b. **LAHSA's Strategic Plan:** Council File Motion 20-0198 The Motion requests the Los Angeles Homeless Services Authority's (LAHSA) Executive Director to provide a presentation to the full

- Council on LAHSA's Strategic Plan currently in development, and on its vision to address homelessness now and in the future. This appears to be dying in committee.
- c. Review Los Angeles City Enhanced Comprehensive Homeless Strategy and LAHSA strategic planning: Council File Motion 20-0042: Council instructs the Chief Legislative Analyst and the City Administrative Officer to: (1) review the Enhanced Comprehensive Homeless Strategy and report on the progress of the ECHS to ensure that each strategy includes measurable goals by which the City can evaluate its progress, assess what is working, and make any recommendations to improve; and (2) monitor the LAHSA strategic planning process to ensure the City's ECHS is complementary with changes to LAHSA programs. We would further add that some time frame should be provided for specified actions. Passed 3/19/20, no indication of any report in file.
- d. Review of Comprehensive Crisis Response Strategy: : Council File Motion 20-0102: the Council shall instruct the Chief Legislative Analyst and the City Administrative Officer to review the Comprehensive Crisis Response Strategy by the Governor's Council of Regional Homeless Advisors and report on the following: 1) defining the City's role in implementing State goals in general; 2) evaluating the City's current Enhanced Comprehensive Homeless Strategy in light of the State's proposal, and 3) ensuring the City is prepared to maximize State funding for our needs. The ENC further suggests that some time frame be provided for specified actions. This passed City Council 2/21/20 when should we expect a report?
