- 1) Call to Order. Roll call; determination of quorum.
- 2) Opening comments from chairpersons
- 3) Reports from Public Officials/Departments/Community Agencies
- 4) Approve minutes of January 13, 2021 Meeting
- 5) New Business (Vote may be taken):
  - a. Determine who want to remain on committee going forward. Discuss possible assignments, for example monitoring expansion of treatment/mental healthcare beds, changes to LPS legislation, etc.
  - b. <u>CF 21-0031</u> Discussion and possible action on submitting a Community Impact Statement (CIS) on Motion 21-0031 (Bonin Raman de Leon Harris-Dawson) relative to directing the Bureau of Sanitation to develop voluntary, service-based protocols for CARE+ operations citywide, as detailed in the Motion.
  - c. CF 20-1376. Discussion and possible action on submitting a CIS on Motion (Blumenfield et al. Cedillo et al.) relative to requesting the City Attorney draft an ordinance that repeals and replaces Los Angeles Municipal Code Section 41.18, in order that it is consistent with the City's current enforcement practice, including with the Ninth Circuit decision in Martin v. City of Boise. It should be noted that a settlement was recently reached in the Boise v. Martin case with the following result: Boise built more shelter space. and a system for locating open beds. Police would be required to confirm that a shelter has appropriate space for a specific person before issuing a citation. People who choose not to go to a shelter when space is available could still be cited. "The codes remain available to the city as a tool to help prevent dangerous encampments in Boise," Scott Muir, assistant city attorney, wrote in a memo to the council. Discussion and possible action on submitting a CIS on The Bonin-Ryu amendment to CF 20-1376: https://clkrep.lacity.org/onlinedocs/2020/20-1376 misc sub%20mo Bonin Ryu 10-28-20.pdf
  - d. AB 71 was supported by the entire LA City council, passing on 3/2/2021 CF 21-0002-S20. This is the tax measure that would add about 2.4 billion per year to the 'Bring California Home Act' fund. It does have vigorous standards for accountability. That said, does it address the issues raised in the recent audit (below).
  - e. <u>Audit of California Response to Homelessness</u>: Discussion. "the State continues to lack a comprehensive understanding of its spending to address homelessness, the specific services the programs provide, or the individuals who receive those services. The homeless council has also not created guidance or expectations for CoCs to follow"
  - f. Discussion and possible resolution: Many cities throughout the country are offering sites for sanctioned encampments. This is clearly a land use issue, but it also allows for concentration of services such as sanitation, counseling, and intake. We have already suggested a couple sites in the north end of the Sepulveda basin for such temporary use. Consider whether the Encino community would have the will to establish such site(s) in Encino possibly an under-used parking lot. Right now, Encino per se has no housing options which might be used to help someone off the street right away.
