2. Approve minutes of April 2, 2019 meeting

April 2019 minutes were approved 6-0-0.



3. Presentation:

Bob Bramen, Co-founder Sherman Oaks and Encino for Quiet Skies

Bob Bramen, Co-founder Sherman Oaks and Encino for Quiet Skies: Mr. Bramen provided updates on how Sherman Oaks & Encino for Quiet Skies was formed, what 2.2 DME/PPRRY flight paths mean to the air noise we are experiencing from VNY Airport, status on LAWA FAA Hybrid Procedure plan, FAA letter to Senators Feinstein and Harris, working with an Aviation Consultant, Status of "Immediate Solutions Panel" being formed, requesting VNY Airport to institute a voluntary late night/early morning curfew, June 3<sup>rd</sup> BUR Airport meeting update, plus updates on the VNY CAC June 4<sup>th</sup> meeting. We continue to need to more individuals to file airplane noise complaints via airnoise.io and webtrack, etc. We need to push to get the above-referenced panel to include VNY Airport activists included. We need to continue to attend meetings such as the VNY CAC and to make our voices heard.

4. New Business: Create a motion regarding late night/early morning voluntary curfew at VNY Aiport:

**MOTION; AIR-19-06-0001:** The Encino Neighborhood Council Airport Committee fully supports a voluntary late night/early morning curfew at Van Nuys Airport from the hours of 10:00pm-7:00am Monday-Friday, and 10:00pm-9:00am on Saturday-Sunday and holidays. Since it is voluntary, there is no downside to businesses, but it has the potential to raise the consciousness of operators and/or customers to at least take into account their responsibility to be a good neighbor. This voluntary curfew excludes emergency services. Moved by: Victoria Miller, 2<sup>nd</sup>: Jim Esterle, Passed: **6-0-0**.

4A. Report on May7, 2019 Van Nuys Airport Community Advisory Council meeting on airport voluntary flight curfew.

The item was moved to the June 4<sup>th</sup> VNY CAC meeting, where it wasn't voted on, and discussion became unproductive.

Many stakeholders (14 in total attended) voiced their concern over the noise issues they are experiencing.
