3A Motion: To support the presentation of the ENC Airport Committee at the Southern San Fernando Valley Airport Noise Task Force Meeting tentatively scheduled for October 2019: **Motion Passes 4-0-0**

4. Updates:

A..VNY CAC meeting of 9/10/19, vote on VNY Airport voluntary curfew: **Issue was continued until 10/01/19 meeting. They are also reposing their Bylaws to include CM Ryu's District 4 to have two appointed seats on the CAC (currently CMs Lee, Blumenfeld, Martinez, Koretz and Krekorian have two appointed seats each). It was also discussed that the CAC should have 18-20 members which are all appointed and that CM Krekorian for example only has one right now instead of the allotted two. The original intent of the CAC founded in the late 80's was to represent citizens and local businesses (not airport businesses) that are impacted by VNY Airport.**

B. Southern San Fernando Valley Task Force on Airport Noise meeting 9/11/19: **Much of the meeting was focused on BUR Airport, not VNY. We need to do better to get the impact that both airports have on Encino. Next meeting is scheduled for Wed. 10/17—*please note the meeting has been postponed since to Wed. 11/06.**

D. Update on the Sherman Oaks Neighborhood Council vote on 9/09/19 to support a VNY Airport voluntary curfew: [The SONC voted in support of the VNY Airport voluntary curfew and CM Ryu \(CD 4 in Sherman Oaks\) sent a letter to the VNY CAC supporting the curfew as well on 9/10/19.](#)
