3. South San Fernando Valley Task Force on Airport Noise Presentation by Robert Bramen

3A. MOTION; AIR-09-19-0003: To support the presentation of the ENC Airport Committee at the Southern San Fernando Valley Airport Noise Task Force Meeting tentatively scheduled for November 2019.

- The 16-minute presentation was shown in it's entirety. There was then a q&a session with those in attendance. Many ideas, suggestions, and commentary were entertained and then there was a motion to amend the motion to include the following items in the final presentation:
- - Open with the goal is to reduce noise
- - Use color for the routes on the black & white map
- - Use a graphic to support 2.2 DME from PRRY—super-impose or an overlay if possible
- -Stress that the noise corridor at or north of the 101 freeway is what we are suggesting
- - Close with returning to the historic routes used
- Amended motion passed: MSP 5-0-0

4. Updates:

- A. CAC meeting of 10/1/19 Voluntary Curfew and By Laws Update.
 - The VNY CAC was created under CM Ferraro in the 80's with the goal of representing residents and businesses that are impacted by VNY Airport. Currently the VNY CAC does not have all 18 positions filled. There is also a request for the Bylaws to be amended to include CD 4 (Ryu) as his district includes Sherman Oaks who are also impacted. CAC member Wayne Willams and HOME President Eliot Cohen met with CM Koretz last week in regard to the Voluntary Curfew and seem to have his support.
- 5. Public Comment on Issues NOT on this Agenda Public Comments on Non-Agenda Items is limited to TWO MINUTES (2) per speaker; total time for all public comment is limited to 10 minutes.  - A dozen speaker cards were presented; most were regarding the Task Force presentation, and a couple were for the VNY CAC including an Outreach Chair for SONC asking for our support of their position to have CD 4 added to the VNY CAC, plus our mutual support of the Voluntary Curfew.
