- 3. New Business (60 Min):

A. Support of the Task Force's 16 point recommendations to the FAA:

Motion: The Encino Neighborhood Council Airport Committee supports the recommendations sent to the Federal Aviation Administration (FAA) from the Southern San Fernando Valley Airplane Noise Task Force (Task Force) to reduce airplane noise. The Southern San Fernando Valley Airplane Noise Task Force voted to send sixteen (16) recommendations to the Federal Aviation Administration on May 8, 2020 to address noise complaints from residents due to changes in flight traffic at both Van Nuys Airport and Burbank Airport.

## B. Overnight voluntary curfew:

Motion: The Encino Neighborhood Council Airport Committee supports strengthening the Voluntary Quieter Nights Program (QNP) at Van Nuys Airport (VNY), and in support of the Van Nuys Citizens Advisory Council's (VNY CAC), requests that Los Angeles World Airports (LAWA) immediately implement the following:

- A. Add helicopters and non-jet aircraft to the QNP
- B. Modify hours for the QNP on weekdays to 10:00PM to 7AM, and on weekends and holidays to 10:00PM to 9:00AM
- C. Provide detailed monthly reports to the Van Nuys Airport Citizen's Advisory
  Committee (VNY CAC), and general public, that document which flights were not in compliance with the voluntary QNP

- C. Updates on Councilmembers, Advocacy, and Residents Groups: Lots of community support, other Neighborhood Councils seems to be taking up some of the issues
- D. VNY CAC meeting review: Last meeting was held on July 7, 2020. VP Wayne Williams ran meeting
- E. VNY, LAWA, FAA Furloughs: None known at this time
- F. VNY Master Plan and Alternative J: More review is needed of the VNY Master Plan and Alternative J Map
