- 2. Discussion and possible action regarding meeting conduct. It has become apparent that the Encino Neighborhood Council (ENC) General Board meetings have been running significantly too long, for a number of reasons. This is not fair to the board members or to the public. After discussion with the Los Angeles City Attorney's office, the following procedural changes to the General Board meetings are recommended. The conduct of Committee meetings is under the purview of the committee chairpersons, but they may adopt these procedures.
 - a. Motion to modify meeting procedure for public comment on agenda items to 1 minute per item with an aggregate limit per speaker of 5 minutes for the meeting. Times may be modified at the Chair's discretion.
 - b. Motion to modify the Standing Rules to allow the public comment on non-agenda items period at any point in the meeting, at the Chair's discretion. This ought to be considered by the Bylaws Committee which is meeting next Friday.
 - c. Motion to eliminate any comment on Reports from Public Officials/Community Agencies other than requests for clarification of information provided (e.g., confirm the date of an upcoming event).
 - d. Motion to request that any board member asking for amendment or substitute motion related to an agenda item requiring a vote provide to the chair the text of the requested change prior to the meeting so the requested change may be distributed to the board. This requirement may be waived by the Chair in the case of exigent circumstances. The entire board should be reminded that we expect most of the items on the General Board Meeting Agenda to have been considered and passed by one of the ENC Committees. The agendas for these meetings are available to the entire board, if a member has an issue with or questions about an item being considered by a committee, that member should weigh in at the committee meeting.
