- a. **Education Committee Mission Statement**

Proposed: The Encino Neighborhood Council's Education Committee represents the residents of Encino in advocating for highly effective and equitable schools.

- b. **Discussion of Neighborhood Purpose Grants for AY 2021-2022**

- i. **Focus area(s):** Propose "...supports the ENC Education Committee mission of highly effective and equitable schools."
- ii. **Maximum award amount:** Propose \$3,000 (we have up to \$7,500 total)
- iii. **Eligible schools (inside/outside of ENC boundary)?**

The ENC Standing Rules read:

"In allocating funding for community projects, the highest priority shall first be given to expenditures that would be for use within the boundaries of the Council. The intent of the program is to provide benefit to the Council's geographic area. An expenditure for use not within the Council's geographic boundaries (such as for schools that are located outside of the Council boundaries but serve Encino children) requires the Council to (i) make findings that the funds are not needed for projects of equal or greater new within the boundaries of the Council, (ii) be supported by a statement of need from the applicant, including disclosure of the participation of the Neighborhood Councils within whose boundary the applicant is located or provides services, (iv) be supported by a letter of acknowledgement from the applicant of the request for the assistance, and (v) be approved by DONE."

- c. **LAUSD Redistricting**

- i. **ENC General Board voted 8-25-21 to support the following statement on LAUSD redistricting:**

Encino has been split between Districts 3 and 4 since the prior map was drawn.

- Whereas being split in two raises the same issues with the school district as it does with the city and all other forms of government: it reduces our ability to act as a unified entity advocating for our kids. Instead, we are split, with one NC managing relationships across two different school board members' offices.
- Whereas the aforementioned split is not even vis a vis geography. One portion of Encino belongs to District 3, an entirely Valley district. The other portion belongs to District 4—which stretches over the hill across a wide swath of Los Angeles with which we have no particular relationship or connection. Critically, we are dwarfed by the dollars and voices on the other side of the hill.
- Whereas our public schools are split between two districts: for example, Lanai Elementary, Hesby Oaks Charter, and Encino Charter are in District 4, while Emelita Charter is in District 3.
- Whereas our public school elementary students are assigned to Portola Middle School (Tarzana), Mulholland Middle School (Lake Balboa), Birmingham High School (Lake Balboa), and Reseda High School (Reseda).

Accordingly, we urge the Commission to create a map that keeps Encino intact, and attached to the Valley neighbors with whom we share school communities, as *one Board District*.
