AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

- 1. Call to Order. Start recording. Roll call. determination of quorum.
 - Meeting called to order at 6:36pm
 - Present were Pat B. Glenn B. & Alex G., quorum met.
- 2. Approval of March 2022 Executive Committee Minutes
 - Pat B. moved, Alex G. 2nds.
 - The item was opened for public comment.
 - No public comment
 - The item passed: 3 (Y), 0 (N), 0 (A)
- 3. Reports from Public Officials/Departments/Community Agencies
 - A. Southern California Gas Company regarding the following project: This pipeline safety improvement project is on the northwest corner of Burbank Blvd and Yarmouth Ave in the city of Encino. This project will improve public safety and is part of a CPUC mandated Pipeline Safety Enhancement Plan. The project is scheduled to start in July of 2022 and take 4-6 months to complete. The street will be under construction for 3-4 months and we have a traffic control plan in place for residents and traffic safety. These plans have been approved by Councilwoman Raman's office, LAPD and LAFD. Notification of this project will be made to residents in a 500-foot radius of the job site.
 - Ben Steinberger from SoCal Gas & Charise & Daniel from SoCal Gas were also in attendance.
 - Glenn B. commented that the reason this project was presented at the Exec Committee meeting was because the regularly scheduled PLU Committee meeting did not make a quorum.
 - Ben introduced the item and Charise explained the details of the project, including the Pipeline Safety Enhancement Plan (PSEP).
 - Following the presentation the item was opened to board member comment.
 - Following board member comment, the item was opened to public comment.
 - No action was taken by the committee
 - B. Other reports.
 - No other public officers/officials were in attendance.

- The minutes have been on the ENC's site and sent to the board for consideration of approval at the regular board meeting.

- Glenn B. provided an update regarding the MER and NPGs.
 - E. Sergeant-at-Arms Report:
 - 1. Discussion and possible action regarding current compliance situation
- The SAA was not in attendance.
- Pat B. mentioned that she does review the DONE site and usually sends out reminders for anyone that has training about to expire.

- 6. New and Old Business Executive Committee
 - A. **Discussion and Possible Action:** Discuss removal of Melody Korehe, Walter Almora and Jonathan Gabriel from Planning and Land Use Committee for failure to complete Planning 101 and other trainings, and for failure to attend meetings. Discuss potential removals from board for failure to attend meetings and/or complete trainings.
 - Pat B. commented that she would prefer to have the conversation with the VP in attendance but did go over the concerns with the amount of meetings missed consecutively. She further commented that there are 2 alternates on the PLU Committee that have not completed the required training and have not met.
 - Glenn B. commented that anyone that has not taken the PLU required training may be removed if it is not completed within 60 days.
 - Pat B. will look for the council file.
 - Glenn B. commented on the removal of Walter Almora based on our Bylaws.
 - B. Discussion and possible action: Motion regarding Burbank Blvd. and Yarmouth Ave. project (see 3.A., above).
 - No action was taken but it was discussed that the link to the Exec Committee would be shared with the board so they can see the presentation before the meeting
 - Alex G. suggested to have the Web Corner add a column so all the links are by the meeting (Agenda, Minutes, Supporting Document, Link to meeting recording).

- C. **Discussion and Possible Action**: Motion recommending the ENC file a Community Impact Statement approving of CF 15-0499-S2, and further asking that it be heard by committee and the City Council expeditiously. The file recommends that Council instructs the Planning Department, the Department of Building and Safety, the Bureau of Street Services, the City's Community Forest Advisory Committee, and. the Board of Public Works Forest Office, with the assistance of the City Attorney, to: (1) prepare a report with recommendations relative to ongoing tree and biodiversity planning, strategies and/or efforts to protect and grow the City's urban canopy, as instructed by the Council on August 12, 2020 (CF 15-0499-SI); and (2) provide recommendations to require the placement of trees, and timing of any tree removals, at an ear phase in the land use/environmental review, and permitting review process, and thereby maximize efforts to grow tree canopy coverage; and (3) prepare and present an ordinance to effectuate these directives.
- Pat B. introduced the item
- Glenn B. although supportive of the item suggested to have the item considered by the Parks Committee.
- Pat B. commented that this is something that the ENC has supported in the past and should be able to come with a recommendation from the Exec Committee and made a motion. Glenn B. 2nds
- The item was opened to public comment, no public comment
- The recommendation to the board passed: 3 (Y), 0 (N), 0 (A)
 - D. **Discussion and possible action:** Digital Communications Policy The proposed Digital Communications Policy was not approved by the Board of Neighborhood Commissioners (BONC), then it was reconsidered on April 5, 2022 and approved as amended without much discussion. The Policy will become effective October 4, 2022, six months after its approval. Prior to BONC approving its policy, the ENC Outreach Committee met and resolved to work on an internal policy. In view of BONC's action, should the ENC weigh in on that action?
- Alex G. introduced the item and discussed the action taken by BONC regarding the communications policy and expressed concerns regarding the policy and what it means for Stakeholders on committees
- Glenn B. further commented about the action taken at the BONC meeting. Recommended to have it as
 an update and to let people know when the workshops are so they can attend and be part of the
 conversation.
- Pat B. agreed to have the item as an update.
 - E. **Discussion and possible action:** NC 2023 Elections The Clerk Clerk has convened an NC Election Work Group composed of NC Board members to provide input on the upcoming 2023 NC Elections. Three voting options are under consideration: an in-person Polling Place for each NC OR only Vote By Mail (VBM) OR a hybrid of in-person and VBM. The 2023 timeline has the Valley's four Regions at the end of the cycle (during June for in-person and hybrid voting or during May for VBM). A 2023 Election survey will be sent soon for NC consideration. In addition, the City Clerk "Election Information Worksheet" including NC Polling Place location/hours and translation requests, will be sent "around June." Both the survey and the Worksheet will need to be agendized for NC action. ENC should consider the formation of an Ad Hoc Election Committee.
- Glenn B. introduced the item.
- Pat B. commented that she will be on the lookout for some of these items and will have the item or part of the item in the May agenda.
- Two members of the public commented on the item, one in favor of in person only and the other for either all mail or combination of mail and in person.
 - F. **Announcement:** DONE has granted us a 30-day extension to submit Bylaws amendments. The second reading will be at the general board meeting of April 27, 2022.
- Pat B. provided an update regarding the extension granted.
- Alex G. asked if we had completed item E, it was unclear if a motion was going to be made
- Pat B. agreed and the motion will be on the agenda.
