IN CONFORMITY WITH THE SEPTEMBER 16, 2021 ENACTMENT OF CALIFORNIA ASSEMBLY BILL 361 (RIVAS) AND DUE TO CONCERNS OVER COVID-19, THE ENCINO NEIGHBORHOOD COUNCIL MEETING WILL BE CONDUCTED ENTIRELY WITH A CALL-IN OPTION OR INTERNET-BASED SERVICE OPTION

Public Comment: Public calling in, please press *9 on your phone to raise your hand to speak. For those that are using the Zoom Webinar please use the raise your hand feature to speak. Public comment on agenda items will be heard when the item is up for discussion. Public comment on agenda items is limited to 1 minutes per agenda item. Comments from the public on agenda items will be heard only when the respective item is being considered. Time may be adjusted at the Chair's discretion.

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Motion, Discussion, and Vote may be taken on all items

1. Call to Order. Roll call, determination of quorum

2. Discussion and possible action on all items:

- a. Article V Section B 1 and B2: Selected Seats: Homeowner Groups (EPOA & HOME) must appoint members for both the Representative and Alternate seats who live and own residential property in Encino
- b. Article V Section B3: Selected Seats: The Chamber of Commerce must appoint members for both the Representative and Alternate seats who work and/or own a business in Encino
- c. Selected Seats Article V: All 3 selecting organizations must provide current membership rolls, plus have an active website confirming the organization's current Board members, provide regular meeting agendas + minutes + invite the ENC Board to all public meetings scheduled. Providing this information will allow transparency, plus validate the individual organization's activity in Encino. This should be provided annually.
- **d.** Article VI Section 1 Officers of the Board: Only Elected Representatives or Selected Organizational Representatives may serve as officers. The positions may not be filled by Alternate Representatives or anyone not serving as a Representative. The assistant secretary position may be filled by any Representative, Alternate Representative, or non-board member Stakeholder.
- e. **Article VIII: Meetings: III.** Meeting conduct: Public comment will not be heard on agenda items which will not result in any action. This includes but is not limited to reports of public officials, officers, and informational presentations. This rule shall be noted in the meeting instructions both at the beginning and end of the agendas.
- f. Standing Rules Article 5, Section 5: Duties and Powers Suggest changing the whole thing to: i. The Board, by majority vote, may select delegate(s) to represent the ENC on Neighborhood Council Alliances, Liaisons, and other working groups. The representative (s) may be removed by majority vote. A roster of Alliances, Liaisons and other working groups shall be maintained on a page of the ENC website. ii. Authorized delegates must vote in meetings outside the ENC in a manner consistent with that of the ENC board if the ENC board has taken a position on the matter. If the matter has not been considered by the ENC, the delegate can vote and should report back to the Executive Committee for inclusion at their next Executive Committee meeting noting the issue, the position taken, and their possible recommendation that the ENC hear the matter. Should the matter subsequently be heard by the ENC board, the result of such action should be conveyed forthwith to the Alliance, Liaison, or working group. Delegate(s) may not assert that any position they take is the official position of the ENC unless such issue has been heard and voted on by the ENC and the delegate is conveying the exact result of that decision. In the absence of such an assertion, any votes or opinions expressed are deemed that of the representative(s). It is strongly recommended that delegates report to the board a brief memo of their attendance at Alliance, Liaison and working group meetings including any votes taken.
