- 4. New Business Motion, Discussion and Votes may be taken on all items:
- A. Election Bus Bench Adverts The board approved funds for up to 6 bus bench adverts to promote our elections. You can view the initial design here: ELECTION BUS BENCH ADVERT. Please note, the QR codes are samples only, the correct codes will be placed prior to production. Discussion and possible MOTION: The ENC's Outreach Committee recommends the board support the Election Bus Bench Advert design and move forward with the approved purchase and installment.
- **B.** USPS Every Door Direct the ENC utilized this service for the last election. The flyers were sent to inform residents that an election was coming up with directions on how to be a candidate, request a ballot and voting information. The mailer previously sent may be viewed here: **ELECTION POSTCARD**. The result was an increase in the amount of candidates yet voter participation was low. In the 91316 zip, 12,226 mail pieces would be sent at a cost of \$2,286.26. In the 91436 zip, 7,427 mail pieces would be sent at a cost of \$1,388.85 If two mailings are conducted, one to generate interest in being a candidate, followed by a 2nd mailing with information on how to vote (in person and mail), the expectation is an increase in voter participation. The total cost to conduct 2 mailings comes to \$7,350.00. We need a total of **40,000** mail pieces the cost cannot exceed \$2000 for printing. If this can be achieved, the total cost would to print and mail 2 sets of election flyers is \$9,350, leaving \$650 for additional outreach efforts. The cost to print 40K pieces may prevent 2 mailings, where are our efforts best utilized; recruiting candidates or getting the word out to vote in the election? **Discussion and possible action.**
- C. Banner at Encino Little League \$1,000 for one 4' x 8' Banner to hang on an ELL field and a logo in the sponsor section of the ELL website. Artwork would be simple, our logo, ENC, www.encinonc.org and the city seal. We could also tie in the election, see sample banner here: ELL ENC BANNER.
 Possible Motion: The ENC's outreach Committee requests that the board approve up to \$1200 for an 8' x 4' banner to hang at a Encino Little League (ELL) field and a logo in the sponsor section of their website.
- D. Election Timeline To help streamline election outreach, should we create a timeline of where we will direct our efforts based on critical election dates. To view our region's timeline, please visit: **ELECTION TIMELINE**. We can target different avenues to get the word out, print, social media, news, radio and others. Discussion and possible action.
- E. ENC Flash Drives Portable flash drives are a great tool to store important information and can be easily placed in a to go bag for an emergency. In addition to being a new give-a-way item at events (especially public safety events), we can pre-load them with NC election information, how to be a candidate, how to request a ballot and

hand them out at any upcoming events. You can see a sample here, <u>USB FLASH DRIVE</u>. Following are two quantity and price considerations; 150 4GB drives from 4Imprint, with the ENC name and website, comes to \$809.20 delivered (\$699 drives, \$30 setup, 10.94 shipping, \$69.26 tax). If this is the desired amount, consider requesting up to \$875 to cover inflated shipping charges. For 200 4GB drives, from 4Imprint, with the ENC name and website, it comes to \$1047.18 delivered (\$916 drives, \$30 setup, \$11.31 shipping, and \$89.87 tax). If this is the desired quantity, consider increasing the request to \$1100 just in case. Possible motion: The ENC's Outreach Committee recommends that the ENC Board approve the purchase of _______ 4GB Logo'd flash drives from 4Imprint and further requests up to ______ to cover the costs. Discussion and possible action.

- **F.** Outreach Event Should we considers hosting an outdoor event, at Encino Park, the Community Center, Balboa Park or other Encino venue to promote the ENC's elections, with an expense up to \$250 (per event) for refreshments? We could potentially host multiple, one to generate candidate interest and one to help residents request a ballot. **Discussion and possible action**
- **G. Pet Adoption Event** Before Covid the ENC attended an event at Fire Station 83, hosted by our Councilmember at the time that was well attended and appreciated. Recently the Commander mentioned that we should have another event at the station with CD4 and our new Councilmember, should we take the initiative and start the ball rolling with CD4. **Explore dates during Discussion and possible action.**
