Public Comment: Public Comments on Non-Agenda Items is limited to TWO MINUTES (2) per speaker. Time may be adjusted at the Chair's discretion. Public calling in, please press \*9 on your phone to raise your hand to speak. For those that are using the Zoom Webinar please use the raise your hand feature to speak.

The amount of time for public comment on each agenda item is to be determined by the Chair at each meeting. Speakers shall limit their comments to matters relevant to the item on the agenda. The Chair may rule that the speaker is out of order if the comments are not germane to the item under consideration. If multiple requests for public comment are submitted on one agenda item, preference will be granted to members of the public who have not spoken previously during the meeting, either during general public comment or on another agenda item.

A member of the public wishing to speak on more than one agenda item at a single meeting shall limit his or her remarks to a total of one minute per item and five (5) minutes per meeting. Members of the public who want to speak on multiple agenda items for up to five (5) minutes at one time can choose to speak during the Multiple Agenda Items Comment period. Otherwise comments from the public on agenda items will be heard only when the respective item is being considered. Members of the public who choose to speak during the Multiple Agenda Items period will be given the opportunity to also speak during General Public Comment. Please be aware that time accumulates for any agenda items commented on. Comments from the public on matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. No individual speaker will be allowed more than two (2) minutes during General Public Comment, unless the presiding officer of the Board decides differently.

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

  - The item was opened to the public
  - Following public comment the item was opened to board member comment. No board member comment
  - Following comments, the item was voted on and passed: 18 (Y), 0 (N), 0 (A)

## **B. Executive Committee**

1. **Motion to file the following CIS**: <u>CF 11-1020-S3</u> would rename the Budget Advocates account to "budget advocacy" with no mention as to where the funds would go. Consider whether to adopt or adopt as modified the following position: The Encino Neighborhood Council opposes Council File 11-1020-S3. Neighborhood Councils form alliances when they want to join together to work on something of common interest. We want to be able to

contribute specifically to alliances we support. The name of the overall fund is not important. What is important is that every recognized alliance has the ability to raise its own funds and those funds are reserved for its use and its use alone. Our Neighborhood Council wants the ability to direct our funds to a specific alliance and not to a fund that is allocated without our input. We ask that the City Council <u>motion</u> contained in CF 11-1020-S3 be amended to make this clear. (Pat/Alex, 5 yes/0 no/0 abstentions)

- Pat B. introduced the item commenting on the council file and the changes requested.
- Glenn B. provided a historical information and further commented on the item.
- Alex G. commented that there is a motion and before discussion we need a 1<sup>st</sup> and 2<sup>nd</sup>., and moved the motion. Henry E. 2nds
- Lee B. attempted to introduce an amendment providing the same information already mentioned by other board members.
- Glenn B. 2nds the amendment
- No other comments from the board.
- A member of another NC spoke regarding the item further shaming DONE
- No other members of the public spoke
- Following public comment a vote on the amendment took place. The amendment was voted on and passed: 18 (Y), 0 (N), 0 (A)
- It was noted that Sam A. joined the meeting, Daniel G. was seated for Sam A., however Sam A. is delinquent with his training.
- Glenn B. could not clarify on the next steps.
- Alex G. asked Sam A., if he would complete the training and join the next meeting.
- Sam A. agreed to complete the training and have the alternate continue in the seat.
- It was noted that Darin S. joined the meeting.

- Alex G. introduced the item, read the recommendation from the committee and moved to approve the motion.

- Pat B. provided clarification on the recommendation
- Victoria M. questioned if this conflicts with the already scheduled cleanups from Robert Newman (an Encino resident hosting cleanups along Mulholland and Ventura Blvd).
- Following board and public comment, the item passed: 19 (Y), 0 (N), 0 (A)

#### 9. NEW BUSINESS:

Parks and Environment Committee:

A. Motion to recommend to the ENC a Community Impact Statement strongly supporting CF 22-0483 and to recommend that Neighborhood Councils are included in all convenings. <u>CF 22-0483</u> instructs the Bureau of Sanitation, in partnership with the Biodiversity Expert Council and the Department of City Planning, to participate in convenings with local and regional jurisdictions, and conservation and environmental stakeholders regarding developing a Regionwide Wildlife Habitat Connectivity Plan. The motion already passed City council 6/29/2022. Pat/Glenn 5 yes /0 no /0 abstentions

**B.** <u>CF 22-0600-S20</u> Instructs the Fire Department to report to the Public Safety Committee on potential partnerships with the Conservation Corps for brush clearance efforts and other outside entities that use goats to eliminate invasive and overgrown brush. (Pursuant to adoption of the Mayor's 2022-23 Budget on May 18, 2022) Motion to recommend the ENC file a CIS supporting CF 22-0600-S20 and include recommend collaboration and possible partnership with additional environmental and community groups including but not limited to the California Native Plant Society and impacted Neighborhood Council(s) Pat/Katie . 5 yes /0 no /0 abstentions

C. <u>CF 22-0600-861</u> instructs the Department of Recreation and Parks (RAP) to report to the Arts, Parks, Health, Education, and Neighborhoods Committee on the feasibility of using wildlife, specifically goats, to support brush clearance activities in parks. (Pursuant to adoption of the Mayor's 2022-23 Budget on May 18, 2022) Motion to Recommend the ENC file a CIS supporting CF 22-0600-S61 and collaboration and possible partnership with additional environmental and community groups including but not limited to the California Native Plant Society (CNPS) and impacted Neighborhood Council(s). Note that in 2021 RAP had an offer from the CNPS to do a 30 acre pilot goat grazing project in the Sepulveda Basin at no cost to the City. Unfortunately, RAP refused without explanation to respond to the proposal.That area is now filled with 6' high dense tinder-dry brush. Pat/Daniel 5 yes /0 no /0 abstentions

- Alex G. commented that items 9A, 9 B & 9C all passed their respective committees following public comment and committee member comment and requested to vote on these as consent items.
- No objections and no comments, items 9A, 9 B, & 9C all passed unanimously, 19 (Y), 0 (N), 0 (A)
- \* Lee Blumenfeld voted on this item but had not completed the City's Anti-Bias (ABLE) training requirement according to the EmpowerLA webpage for the Encino NC as of the start time of the meeting

## **Outreach Committee:**

D. MOTION: The ENC's Outreach Committee recommends that the ENC approve the following locations, for in person voting on June 18, 2023: LAFD Station 83, 4960 Balboa Blvd., Encino, CA 91436 as the primary location and the Balboa Sports Complex, 17015 Burbank Blvd., Encino 91316 as the backup location for in person voting with hours of operation set from 10am – 4pm. Alex G. moved, Pat B. 2nds, passed 5 (Y), 0 (N), 0 (A)

#### E. <u>CF 21-1472</u> - To Rules, Elections, and Intergovernmental Relations Committee

Motion (Raman - Krekorian - Martinez) relative to instructing the Chief Legislative Analyst, with assistance from the City Attorney and other departments, as needed, to report with options for a ballot measure for the November 2022 ballot, to amend the City Charter to create an Independent Redistricting Commission for the City. **MOTION: The ENC's Executive Committee recommends that the board is in support of CF 21-1472 to amend the City Charter to include an independent redistricting commission for the city. Alex G. moved, Pat B. 2nds. Passed: 5 (Y), 0 (N), 0 (A)** 

- Alex G. introduced the item, read the motion and moved. Glenn B. 2nds
- Glenn B. provided historical info regarding the motion
- Lee B. requested to copy the Mid-City NC, once again hindering the pace of the meeting.
- Alex G commented that this could have been brought up before and also commented that when the agenda was sent it was noted to read the agenda and send comments in regarding this specific item, Lee B. failed to do so, disrupting the meeting, once again, and that at this time we want to get a report back without having to define the specifics of the item
- Glenn B. was in agreement with the President's comments

- Pat B. also agreed with Alex G's comments
- A member of the public spoke on the item asking how it can be determined how many districts there would be
- Glenn B. provided clarification
- Two more members from the public spoke
- Following public comment, Alex G asked if there was a 2<sup>nd</sup> to Lee B's request.
- A 2<sup>nd</sup> was not received for the amendment
- The original item was voted on and passed: 19 (Y), 0 (N), 0 (A)
- \* Lee Blumenfeld voted on this item but had not completed the City's Anti-Bias (ABLE) training requirement according to the EmpowerLA webpage for the Encino NC as of the start time of the meeting

**F. Elections, Section 4.** [Method of Verifying Stakeholder Status - Voters will verify their Stakeholder status by providing acceptable documentation.] Verification of registered Los Angeles County voter status at an Encino address shall be an acceptable documentation method for resident Stakeholder status. **MOTION: The ENC's** 

Executive Committee recommends that the board support requesting that the City Clerk incorporate voter registration as a method of verification of eligibility for neighborhood council elections. Pat B. moved, Alex G. 2nds. Passed: 5 (Y), 0 (N), 0 (A)

- Alex G requested to continue the meeting for another 20 minutes, introduced the item.
- Pat B. further provided comments regarding the item
- Alex G. read and moved the motion. Henry E. 2nds
- Glenn B. provided clarification
- The item was opened to public comment
- A member of the public meeting.
- Following pubic comment the item was voted on and passed: 17 (Y), 0 (N), 2 (A)
- \* Lee Blumenfeld voted on this item but had not completed the City's Anti-Bias (ABLE) training requirement according to the EmpowerLA webpage for the Encino NC as of the start time of the meeting
