- 6. New and Old Business Executive Committee
  - **A. 2023 ENC Regular Meeting Schedule -** For most of the year our regularly scheduled meetings do not conflict with major holidays. Our June meeting will be on the 28th, it could include a Special meeting with the newly elected board. November has 5 Wednesdays, we could have our last meeting on Nov. 29, 2023, with the Exec on Nov. 14, 2023. **Discussion and possible action.**
  - B. CD6 Candidate Forum There will be a CD6 candidate forum, tentatively on Feb 18th, we have been invited to participate and have a table with our NC and election info. Since Encino shares jurisdiction of the Sepulveda Basin with Lake Balboa, it is imperative that we work closely with the new Councilmember. Discussion and possible action to secure funding for refreshments and election flyers at our table with the following possible MOTION: The ENC's Executive Committee recommends that the board authorize up to \$350 for election information handouts and refreshments for our table at the CD6 Candidate Forum, on February 18, 2023 at the Osborne Neighborhood Church, 13501 Osborne St., Arletea, 91331.
  - C. West San Fernando Valley Disaster Preparedness Fair There will be a West San Fernando Valley Disaster Preparedness Fair at Pierce College on Feb 25. As of Jan 13, I was informed that there is still a possibility of sponsoring a table at the event. If indeed we're able to attend, should we prepare a motion requesting funding in the amount of, up to \$2000? Discussion and possible action.

- D. Drone for West Valley LAPD Several cities, including Los Angeles, have started using drones to assist law enforcement officers on calls. Beverly Hills PD is currently using a drone called "Hawkeye" and reported a decrease in crime since the real-time monitoring started between January and October 2022. During that time, there were 2,384 flights, including responding to 1,283 calls from the police radio. About 674 times during that period, the drone arrived on scene before police officers. The drone was also used 317 times to keep an eye above traffic stops initiated across the city (LA Times, Dec. 29, 2022). While other divisions can launch the drone from the patrol vehicle. Currently the LAPD is severely understaffed, the use of a drone for the West Valley LAPD station would greatly assist our officers. Should the ENC recommend the following:
- Have our Councilmember introduce a motion requesting the Police Commission expand the drone program to assist West Valley LAPD officers
- Request that the Budget Advocates add at least \$500,000 to the LAPD Budget for the use of one Hawkeye or similar drone for the West Valley LAPD
- Submit a community impact statement to the Police Commission recommending the use of drones at the West Valley LAPD station and expand the program to include assistance to officers for any call in which utilizing a drone will aid officers.

## Discussion and possible action.

- E. In person meetings On January 13, 2023 we received communication that in-person meetings will resume, for all Brown Act bodies in the State, on March 1, 2023. The Encino Community Center (ECC) will be inspected on the 17th in preparation for meetings. Currently the ECC requires proof of vaccination to enter the building, potentially limiting public attendance, including current board members. Discussion and possible action
- F. Committee Chair/Board Retreat With in person meetings returning, it is a good time to have a Committee Chair/Board Retreat. Retreats provide an open environment to go over best practices, share ideas and familiarize us with the procedures from motion to CIS, to change. A retreat could be held at a park (Encino or Los Encino) and we would be able to provide refreshments for the retreat. As a precaution it may be wise to request board approval for refreshments funds in the amount of up to \$500. Discussion and possible action

  Resolution (Soto-Martinez Raman for Lee Yaroslavsky) relative to including in the City's 2023-24 State

  City of Los Angeles Neighborhood Council system to choose to operate remote meetings indefinitely. Should
  the ENC file a CIS regarding this council file? Discussion and possible action
- H. CF 23-0002-S17 To Rules, Elections, and Intergovernmental Relations Committee Resolution (Blumenfield - Krekorian - McOsker) relative to including in the City's 2023-24 State legislative Program its position on legislative action that would amend the Ralph M. Brown Act to allow local legal legislative bodies, including appointed boards, commissions, advisory bodies, and Neighborhood Councils, to continue to meet virtually. Should the ENC file a CIS regarding this council file? Discussion and possible action.

J. ENC COUNCIL DISCUSSION AND TIME LIMITS - A contributing factor to meetings running late is in part because councilmembers take an inordinate amount of time speaking on an item and often speak multiple times per item or attempt to have back and forth discussions. The following is taken from the LA City Council agenda: Councilmembers requesting to address the Council will be recognized by the Council President in the order requested. For any item, the Chairperson of the Committee, or the maker of the original motion, or the member calling a matter "special" shall have up to six (6) minutes to discuss the item. All other Councilmembers may speak up to three (3) minutes each on the matter. After all members desiring to speak on a question have had an opportunity to be heard once, the time for each Member desiring to speak again shall be limited to a maximum of three (3) minutes.
