#### 6. New and Old Business Executive Committee

- A. Los Encinos/Shakespear by the Sea 2023 -. Los Encinos State Historic Park usually hosts a Shakespeare by the Sea production, with contributions from partners, including the ENC. A decision was made to stop the event at the Historic Park, leaving the production without a location. Should the ENC attempt to host the event, perhaps at Encino Park, The Velodrome, Balboa Sports Complex or other Encino location? The ENC usually supports the production with up to \$5000 for related costs. Discussion and possible action.
- **B. Planning Events for 2023 -** The ENC usually hosts a movie at the park towards the end of July but have been discussing later in the year to help with lighting. The Encino Family Festival will not return, it was discussed in Outreach to host a large community event, perhaps a winter carnival/festival with real snow. However, with the election, planning something for a new board and new budget presents challenges, how can we plan for events past July? **Discussion and possible action.**

The project is being presented as a community beautification/improvement project. It is about 25% visible from Ventura Blvd. The mural is on private property and the design cannot be changed.
