- 4. New Business Motion, Discussion, and Voting may be taken on all Items:
 - A. Discussion and possible motion to support the LAFD CERT emergency response drill at Encino Park on May 18, 2024 authorizing funding of up to \$500 for refreshments for participants, color coded wristbands, signage and expendable medical supplies. Encino NC will use this event to promote participation of local residents in preparing for and responding to disasters..
 - B. Discussion and possible motion regarding the "old" Fire Station, 5001 Balboa Blvd. Encino, CA 91316, see CF 13-0476 and ZIMAS permitting information (indicating that construction is perhaps imminent). The location has been plagued for many years by break-ins, squatters, fires, graffiti, and unkempt vegetation. The adjacency of the property to an Elementary School is troubling. In addition, it appears that in mid-2021 the terms of the original lease were modified, and there does not appear to have been an updated term sheet published to CF 13-0476 or following, and the lease including Exhibit X have not been provided to the public. Consider a request, possibly by a CIS to CF 13-0476 that, at minimum, a current Term Sheet and preferably the final lease for this publicly-owned property be provided, as well as contacts at the lessee organization responsible for rapid response to issues at the property. Any comments from the lessee or the City Council on this matter are welcome.
 - C. Discussion and possible motion regarding Encino Neighborhood Watch (NW) Groups. Committee member Roy Nwaisser will describe his website created to assist with NW

formation. A request will be made to have LAPD available at the meeting (or a later meeting) to comment on NW groups, ways to access them, and how can NW be combined with RYLAN.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that

prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

- (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.
- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
- (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph
- (D), to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public

comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
