IN CONFORMITY WITH GOVERNOR NEWSOME SIGNING SB411 INTO LAW ON OCTOBER 9, 2023 AND IN COMFORMITY WITH THE LOS ANGELES CITY COUNCIL PASSING CF 23-1114, THE ENCINO NEIGHBORHOOD COUNCIL MEETING WILL BE CONDUCTED ENTIRELY WITH A CALL-IN OPTION OR INTERNET-BASED SERVICE OPTION

Public Comment: Public Comments on Non-Agenda Items is limited to TWO MINUTES (2) per speaker. Time may be adjusted at the Chair's discretion. Public wishing to speak on non-agenda items will fill out a speaker card and turn it in to the Secretary.

The amount of time for public comment on each agenda item is to be determined by the Chair at each meeting. Speakers shall limit their comments to matters relevant to the item on the agenda. The Chair may rule that the speaker is out of order if the comments are not germane to the item under consideration. If multiple requests for public comment are submitted on one agenda item, preference will be granted to members of the public who have not spoken previously during the meeting, either during general public comment or on another agenda item.

A member of the public wishing to speak on more than one agenda item at a single meeting shall limit his or her remarks to a total of one minute per item and five (5) minutes per meeting. Members of the public who want to speak on multiple agenda items for up to five (5) minutes at one time can choose to speak during the Multiple Agenda Items Comment period. When turning in the speaker card, indicate which items you wish to speak on. Otherwise comments from the public on agenda items will be heard only when the respective item is being considered. Members of the public who choose to speak during the Multiple Agenda Items period will be given the opportunity to also speak during General Public Comment. Please be aware that time accumulates for any agenda items commented on.

Comments from the public on matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. No individual speaker will be allowed more than two (2) minutes during General Public Comment, unless the presiding officer of the Board decides differently.

9. NEW BUSINESS - FUNDING:

A. One Generation Senior Symposium – Once again we are able to table at the One Generation Senior Symposium. The ENC has been participating each year for several years. One Generation draws large crowds to their event, with a large percentage of Encino residents attending. The cost to table is \$1000, see supporting document: One Gen Invoice. MOTION: The ENC's Executive Committee recommends that the board support participating in the One Generation Senior Symposium, on May 18, 2024 at the One Generation Campus located at 17400 Victory Blvd., Van Nuys 91406 and approve the cost of \$1000 to table at the event. Passed: 5 (Y), 0 (N), 0 (A).

B. Community Meetings for Public Safety & Disaster Prep – To schedule and support Encino NC Area meetings addressing public safety with LAPD and possibly other city agencies including LAFD

and LA City EMD, including possible motion authorizing funding up to \$500 for meetings, publicity, refreshments, and materials expenses, with possible budget reallocation to support such meetings for each Area, up to \$500 per area and an aggregate of \$3,500. MOTION: to recommend the ENC support 3 community meetings addressing public safety and disaster preparedness with LAPD, EMD, LAFD and any other relevant agencies including up to \$500 per meeting for refreshments, publicity, materials and any related costs. The three meetings will alternatively target the following segments of our Encino community: Multi-Family residents and property owners/managers, Single-family residents north of Ventura, and single-family residents south of Ventura Blvd. Pat/Varant Motion passed 6 yes 0 no 0 abstentions

10. NEW BUSINESS CONSENT ITEMS: Items 9A. thru 9D. all passed their respective committees with full consent, following discussion by committee members and the public. Public comment was taken on all of the following consent items in committee. Unless a board member pulls an item, items 9A. thru 9D. will be deemed approved unanimously by the Encino Neighborhood Council. If an item is pulled, the remaining consent items will pass by consent and the pulled items will be discussed in the order on the agenda. All from Public Safety except 9D.

9A. Council File 24-0036 Solar Power Street Lights – MOTION: To recommend that the Encino Neighborhood Council (ENC) board file a Community Impact Statement (CIS) supporting Council File 24-0036, requesting that the Bureau of Street Lighting report on the feasibility of installing solar-powered street lights when responding to lighting outages caused by copper wire theft or other maintenance issues, and further report on the feasibility of converting to solar-powered lighting throughout the City. Pat/Varant Motion passed 6 yes 0 no 0 abstentions. Approved.

9B. Motion to recommend the ENC board file a CIS opposed to the City Emergency Management Department 2024-2025 budget unless amended to include three new positions (draft motion is attached to this agenda), which are reportedly not included in the draft budget. This will attach to Council File 24-0600 (likely) when opened and will be opposed to the EMD budget unless amended to include these positions. Pat/Varant Motion passed 6 yes 0 no 0 abstentions Motion to support if amended.

9C. Motion to recommend the ENC file a CIS opposing unless amended the LAFD budget for fiscal year 2024-2025 unless positions for CERT training are restored to 7 instructors. This will attach to Council File 24-0600 (likely) when opened. Pat/Varant Motion passed 6 yes 0 no 0 abstentions Motion to support if amended

MOTION PASSES: 16 YES

9D. Ventura/Cahuenga Corridor Specific Plan, CF-17-1071-S1, — Encino is 3.47 miles of the 17 miles of the Ventura/Cahuenga Corridor Specific Plan. Since redistricting, in over a year, Encino has had no representation on the VCCSP and must be corrected. MOTION: The Encino Neighborhood Council supports proposal to have a 13-member Ventura-Cahuenga Corridor Specific Plan (VCCSP) Review Board consisting of 1 mayoral appointee, 1 from each of the 6 communities appointed by the councilmember(s) of each community, AND 1 from each of the 6 communities appointed by the Neighborhood Councils of each of the 6 communities. If any of the 6 communities is represented by more than 1 councilmember, the multiple councilmembers of that community shall jointly choose that community's councilmember appointee regardless of where the VCCSP boundaries fall in that

community. The above insures that even if the whole VCCSP was in the same Council District, (and that's not an impossibility in 2031 or any other decennial census redistricting year, given that CD4 is currently over 17 miles long), that the single councilmember could still only appoint 6 out of 13 members. Without the above, a single Councilmember could appoint 12 out of 13 members (a majority). If there were a 7-member VCCSP Review Board without Neighborhood Council appointees, that same councilmember could appoint 6 out of 7 members (also a majority). Additionally, the community of Encino must be represented by, at least, 2 Encino residents. Passed: 5 (Y), 0 (N), 0 (A)
