#### 4. New Business – Motion, Discussion, and Voting may be taken on all Items:

- A. **Agenda Protocol -** A discussion on establishing a clear protocol for posting agendas both online and on the Encino Neighborhood Council website to ensure timely and consistent communication. The committee will review current practices, ensure all members are aware of the proper procedure, and potentially create a new protocol to prevent meetings from being canceled due to agenda-related issues. This will include setting clear deadlines and responsibilities for agenda preparation and posting. **Discussion and Possible Action.**
- **B. Video Participation During Meetings -** Discussion on enforcing the requirement for all members to have their video on during Encino Neighborhood Council meetings. This will ensure active participation and accountability. The committee will address any concerns or exceptions and establish guidelines for consistent video presence throughout the meetings. **Discussion and possible action.**
- C. **Hybrid Meetings and Equipment Review -** Discussion on the possibility of holding hybrid meetings for the Encino Neighborhood Council. Prior to making a decision, the committee will review the available equipment to assess what is required for implementation. Additionally, the status of the equipment storage will be addressed, including whether the cage in the office has a separate lock and if the key is included on the council's keychain. **DISCUSSION AND POSSIBLE ACTION.**

A motion to make a limited amendment to Article X Section 4 of our Neighborhood Council Bylaws - The motion would be to change the ENC stakeholder verification method from documentation to self affirmation for the upcoming 2025 Neighborhood Council vote-by-mail elections. #### SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service. Actions taken on agenda items during a disruption that

prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

(D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph

(D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
