A. Meeting Security and Participation: The need for unified communication and collaboration should be emphasized to all members to prevent further interference and maintain the integrity of the meetings. Clear expectations and consistent engagement are essential for moving forward as a cohesive team. **Discussion and Possible Action.**

B. Support for Draft 3 of Housing Element/CHIP Ordinance: - The Encino Neighborhood Council strongly supports City Council approval of Draft 3 of the Housing Element/CHIP Ordinance, as presented by the Planning Department, and approved by the Planning Commission, without regard to the Exhibit D "options" that would open up single-family neighborhoods to impactful high density housing. The Planning Department in its report clearly states that they have found enough zoning to meet the State's mandate for housing without the need to rezone our single-family neighborhoods. **Discussion and possible action.**

C. Review status of board members - Discussion on the current status of multiple board members. **Discussion and possible action.**

5. Review ENC Regular Board Meeting Agenda.

- A. CIS on Homelessness:** The status of the Public Safety Community Impact Statement (CIS) on homelessness requires review and discussion. An update on its progress or a copy of the CIS is needed for review to ensure alignment with the council's position and to determine any necessary next steps. If anyone has access to the document, it should be shared to facilitate further discussion. **Discussion and Possible Action.**
- B. Presentation from Marcelino Ascencio about the LA River Bike Path Project Update (Vanalden Ave to Balboa Blvd.):** The project manager for the LA River Bike Path – Vanalden Ave to Balboa Blvd. (Segments 1 and 2) has requested to present updates at the upcoming General Board Meeting on Wednesday, October 23, 2024. This project is part of the larger LA River Bike Path network, aiming to connect the LA Riverway from the San Fernando Valley to Griffith Park and, ultimately, to the Pacific Ocean. Background: The project involves the construction of a Class I bike lane and greenway along the LA River from Vanalden Ave. to Balboa Blvd. Additional elements include a bridge, sidewalk improvements, new traffic signals, stormwater bioretention basins, lighting, fencing, and six under-crossings through the LA River's trapezoidal channel. Construction documents are 100% complete, and the project is anticipated to go to bid in November 2024.
- C. CF19-1020: CIS of Support and Councilperson Advocacy:** We have received a request from Amos Marvel of the Reseda Neighborhood Council to join a Community Impact Statement (CIS) for CF19-1020, a motion introduced by Mike Bonin on September 4th, 2019, to establish a "Commission for Lived Experience with Homelessness" (CLEH). This advisory board would be composed of current and former unhoused individuals and would focus on identifying service gaps, improving program efficiency, and finding cost-saving opportunities for the city. Several other Neighborhood Councils, including Reseda, Sherman Oaks, Hollywood United, and MidCity, have already joined the CIS. With only eight weeks before the motion expires in City Council, we need to vote on whether to support this initiative.
- D. Appoint Paul Zablidowsky as new ENC Volunteer Representative:** Paul has submitted an application and I have reviewed it. It will be made available for the public to view on the board agenda.
- E. Funding Items:** 1. Motion to approve September MER. 2. Motion to approve purchase up to \$250 for internet wifi extenders and ethernet switch network hub station and batteries to allow ENC hybrid board meetings. **If we have to call a special board meeting please add this so I can generate a SEPT MER. I can't do that until this charge is approved by the board. 3. Motion to approve reimbursement of \$13.69 to Roy Nwaiser for copies of printed agendas for the September in-person board meeting.

F. Rob Glushon presentation: Rob Glushon will give a 10 minute presentation on the topic of the City Council approval of Draft 3 of the Housing Element/CHIP Ordinance, as presented by the Planning Department, and approved by the Planning Commission, without regard to the Exhibit D “options” that would open up single-family neighborhoods to impactful high density housing.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that

prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

(D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph

(D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
