- 2. **Public Comment on Non-Agenda Items –** Public Comments on Non-Agenda Items is limited to TWO MINUTES (2) per speaker. Time may be adjusted at the Chair's discretion. - 4. New Business Motion, Discussion and Voting may be taken on all items:
 - **A. Encino Fest Planning and Coordination**: Review the current status of Encino Fest, which is taking place this month. Go over finalized plans, identify any outstanding needs, and ensure full engagement from the committee. Discuss marketing strategies and assess whether additional sponsors or funding are necessary. Clarify logistical details for the day of the event, including specific volunteer roles, staffing locations, and responsibilities. Determine how to involve new candidates as volunteers and identify which ENC members will be participating and in what capacities. **Discussion and possible action.**
 - **B.** Upcoming Election and Candidate Forums: Vote-by-mail began on April 4th, and we are planning to hold three in-person candidate forums to engage the community and introduce the candidates. To proceed, we will need to either organize events or hold special Outreach Committee meetings. Proposed dates for the forums, based on availability and venue access, are Sunday, May 4th; Sunday, May 18th; and Sunday, May 25th. If held on Sundays, the forums can take place at the Women's Center. During this meeting, we will discuss logistics, format, and promotion strategies for the forums to ensure strong attendance and community involvement.
 - **C. Outreach plans for future events List of the events:** Friends of the LA River. Saturday, April 26th at the Sepulveda Basin Wildlife Reserve, and the tabling commitment is from 7am-1pm. Fourth Annual Valley Day of Service on Sunday, May 4th at Pierce College. ONEgeneration's 16th Annual Senior Symposium on Saturday, May 17th, 2025. Let's also discuss events that are not included above.
 - **D. ENC Newsletter Relaunch:** It's time to resume our newsletter, as it's been a while since the last one. We should prioritize content that promotes the upcoming election, introduces the candidates, and highlights EncinoFest. Let's discuss timeline, content, contributors, and distribution methods to ensure a successful and informative release.
 - **D.** EncinoFest Recognition Certificates from Assemblymember Jesse Gabriel: Assemblymember Jesse Gabriel's office will be providing certificates of recognition for individuals and groups who contributed to the success of EncinoFest. We need to identify recipients such as the DJ, band, local schools, dancers, balloon artists, and any other key participants. Let's compile a full list and finalize it for submission.

- **E. Planning the Next Movie Night:** It's time to begin discussions for our next community movie night. If we plan to hold it within the next few months, we should start now by brainstorming potential dates, locations, film options, partnerships, and promotional efforts to ensure another successful event.
- **F. Citywide Banners and Signage for Outreach:** We'd like to put up banners around the city to promote events like EncinoFest and the election—on bus stops, street poles, traffic lights, and street lamps. Let's discuss the process for obtaining permits or approvals, design and messaging, and how to move forward effectively.

2025 Election Timeline and Election Handbook – The 2025 ENC elections are around the corner, please review the election handbook and timeline to become familiar with all things election. Encino is in Region 3.

The Encino Neighborhood Council (ENC), is a Certified Neighborhood Council of the City of Los Angeles which ADVISES City, other Governmental Officials' and the Community on issues or concerns that are affecting the community of ENCINO. The ENC is made up of volunteers who are ELECTED by the community who live, work or otherwise are involved in the community of ENCINO. The ENC also makes appropriations of City Funds for Community Projects and needs as requested and approved by various committees and the general board.

IN CONFORMITY WITH THE OCTOBER 6, 2023 ENACTMENT OF CALIFORNIA SENATE BILL 411 (PORTANTINO) AND LACITY COUNCIL APPROVAL ON NOVEMBER 1, 2023, THE ENCINO NEIGHBORHOOD COUNCIL MEETING WILL BE CONDUCTED VIRTUALLY.

Public comment is limited to one (1) minute per speaker per item, unless adjusted by the presiding officer of the Board or Committee. Consent items which have been unanimously approved by a public committee meeting are exempted unless pulled from the consent section by a Board member.

- **SB 411 Updates:** In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.
- (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.
- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
- (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
