Neighborhood Purposes Grants

Neighborhood Purposes Grants (NPGs) provide NCs opportunities to develop partnerships with local 501(c)(3) nonprofits and public schools to build community and enhance neighborhoods in the City of Los Angeles. Projects and activities supported by NPGs vary widely and can include, but are not limited to:

- The Arts
- Beautification
- Community Support
- Education
- Community Improvements

NPG-funded projects and activities must be for a *public benefit* and purpose, **open**, *accessible*, and *free of charge* to stakeholders.

Grants approved by NCs exceeding \$5,000 involve further review and possible City contract by the Office of the City Clerk.

There are two NPG Information Packets; One for prospective applicants to help guide them in the application process, and one for NC board members outlining considerations and factors to keep in mind while evaluating NPG requests.

A "Project Completion Report" template is also provided to help ensure accountability in the use of Grant funds and help demonstrate how NCs and their partners are supporting L.A. communities and stakeholders. NCs and NPG recipients are strongly encouraged to work together to complete and submit the Report at the conclusion of the project.

Dear Applicant:

Based on information you supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).

Because you are a newly created organization, we are not now making a final determination of your foundation status under section 509(a) of the Code. However, we have determined that you can reasonably expect to be a publicly supported organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

Accordingly, during an advance ruling period you will be treated as a publicly supported organization, and not as a private foundation. This advance ruling period begins and ends on the dates shown above.

Within 90 days after the end of your advance ruling period, you must send us the information needed to determine whether you have met the requirements of the applicable support test during the advance ruling period. If you establish that you have been a publicly supported organization, we will classify you as a section 509(a)(1) or 509(a)(2) organization as long as you continue to meet the requirements of the applicable support test. If you do not meet the public support requirements during the advance ruling period, we will classify you as a private foundation for future periods. Also, if we classify you as a private foundation, we will treat you as a private foundation from your beginning date for purposes of section 507(d) and 4940.

Grantors and contributors may rely on our determination that you are not a private foundation until 90 days after the end of your advance ruling period. If you send us the required information within the 90 days, grantors and contributors may continue to rely on the advance determination until we make

Mission Statement and description of community event, including Estimated attendance: Shakespeare by the Sea is a 501(c)3 non-profit organization, with a mission to bring classic works to culturally diverse, multi-generational audiences in order to ignite imagination, promote literacy, and encourage artistic expression. SBTS has been enriching the lives of community members throughout L.A. County with admission-free Shakespeare performances since 1998.

Description of proposed event, including benefits to the community:

Shakespeare by the Sea is a FREE Public Arts event - Performance of a Shakespeare play for the community to experience together. Since 1998, we've delivered these events at neighborhood Parks throughout LA County. We do this nightly in over 16 communities each summer. The event is a public benefit, ticketless, open and free for all attendees. Admission FREE Shakespeare provides an opportunity for residents and local visitors to experience a professionally produced Shakespeare play while engaging with other community members in their neighborhood parks. The program not only offers cultural arts enrichment, the events provide a communal space for a multi-generational audience comprised of those without resources, as well as those with the means, to attend live theatre. We are committed to enhancing the arts and culture landscape of all the areas we serve and contributing positively to the social infrastructure - improving livability, inspiring civic engagement, and contributing to healthier, longer lives of residents. Our programs have reached over 585,000 diverse audience members, theatre professionals, and community volunteers.

Attendance:

Because we are admission-free and ticketless, we can estimate attendance. Based on historical data of past events, we an estimated 300 members of the general public + (25) Staff/Artists & Community Volunteers will benefit from event.

Reasons why the event should be considered for sponsorship:

Admission FREE Shakespeare is not free to produce. We need financial support from local stakeholders to support the performances in each location we tour to. Funding helps underwrite payroll costs for actors, designers, technical artists; sets, props, costumes; event equipment and truck rental costs; insurance, marketing & promotion to the local community.

SBTS will spend \$13,435 to bring this program to Encino. Performances elsewhere in LA County are partially supported by Tour Fees from those city/community hosts in the range of \$7500-9000 per night. No tour fee has been secured for Sepulveda Garde Center and, in addition to the usual program costs, there are unique expenses for serving the public at this location. SBTS will be responsible for paying permit fees, providing a generator and toilets

for the attendees - services that are typically provided by the hosts in other tour cities – as well as banners, which will help promote the location to new audiences in Encino who may not already be in the SBTS 15,000 person database.

SBTS has a 27-year history of activating numerous parks with arts and culture events, providing cross-cultural connections and exposure to live theatre. Each year, we look for new venues and neighborhood partners to reach a broader audience.

SBTS is committed to producing these events and is enthusiastic that Sepulveda Garden Center will allow us to benefit an established and beloved audience in LA County.
