1. Call to Order / Roll call / Determination of quorum

2. Comments from chair -

Street safety updates:

- After pressing Nithya Raman's office, we got a growing sinkhole on Petit fixed.
- Still getting promises for action from Nithiya Raman's office on very dangerous conditions causing slick roads and property damage on Ballina Canyon & Red Rose, but still no action.
- Speed hump program has been discontinued.

Due to the City's budget crisis, last Thursday, the City Council's five-member Budget Committee proposed a plan to cut LAPD ranks by 300 officers. In 12 months, that will leave the department with 8,400 officers which is down from 8,700 officers this year. 8,400 would be the lowest officer level since 1995.

5. Legislative Considerations

A. <u>Council File: 25-0445</u> - Integration of data silos containing data about homelessness into the city's Homeless Management Information System (HMIS).

The data from agencies that provide homelessness services and housing in the City is not uniform or integrated into a cohesive system, often resulting in "data silos" or repositories of data that are mutually incompatible. Integration of this data into the HMIS will streamline data collection and result in more efficient and effective analysis.

MOTION: Encino Neighborhood Council Public Safety Committee recommends the ENC submit a CIS supporting Council File: 25-0445 which identifies homeless data silos that can be integrated in order to improve data analysis and improve homeless system operations. (Nwaisser/Sauttter)

6. Update on Former LAFD Station 83 by Armenian Cultural Foundation Representatives

The Public Safety Committee will receive a presentation from the Armenian Cultural Foundation by Shant Hagopian Esq (ACF Board Member) and Raffi Sarkissian (ACF Chairman), providing an update on the former site of LAFD Station 83 (NW corner of Balboa Blvd and Addison St).

A follow-up to last year's presentation, this will address ongoing community concerns, including reports of fires, break-ins, drug use, and water pipe bursts at the site which is adjacent to the Encino Charter Elementary School.

Questions from the committee and the public will follow the presentation.

ACF reports that construction was significantly delayed due to historical designation of fire station and permitting process. Constuction started in February 2025 and they expect the project to be complete in the next few months. Security cameras will be installed all over. Security guards will be hired depending on need and cost. Facility will be available to all community members, not just Armenians.

7. CPR/First Aid Certification

Cost: \$85 per person for CPR (4 hours) or \$115 for CPR + First Aid (5 hours)

Minimum 10 people up to 25

We want there to be CPR but it might not be possible for ENC to pay for it. So maybe ENC covers venue costs and promotes it, but people will have to pay for their tuition.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

- (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.
- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
- (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph
- (D), to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
